EOG Resources, Inc. (OGRID No. 7377) seeks administrative approval of an unorthodox well location for its **Jupiter 19 Fed Com #306H well** (API No. 30-025-48239) to be completed within the Red Hills; Bone Spring, North Pool [96434], in a 480-acre, more or less, spacing unit underlying the E/2 of Section 19. and the NE/4 of Section 30, Township 24 South, Range 34 East, N.M.P.M., Lea County, New Mexico.

This well is drilled and is to be completed as follows:

- the surface location is located 563 feet from the north line and 2335 feet from the east line (Unit B) of Section 19,
- the bottom hole location is located 2540 feet from the north line and 2585 feet from the east line (Unit G) of Section 30,
- the first take point is located 100 feet from the north line and 2585 feet from the east line (Unit B) of Section 19, and
- the last take point is located 2540 feet from the north line and 2585 feet from the east line (Unit G) of Section 30.

Since this acreage is governed by the Division’s statewide rules, the completed interval for this well will be unorthodox because it is closer than the standard offsets to the western boundary

of the spacing unit at the first take point and encroaches on the spacing unit in the W/2 of Section 19 and the NW/4 of Section 30. Approval of the unorthodox completed interval will allow EOG to use their preferred well spacing plan for horizontal wells in this area and thereby prevent waste.

Exhibit A is a Form C-102 showing the completed interval of the proposed **Jupiter 19 Fed Com #306H well** encroaches on the spacing unit/tracts to the west in Sections 19 and 30.

Exhibit B is a plat for Sections 19 and 30 that west the proposed **Jupiter 19 Fed Com #306H well** in relation to adjoining spacing unit/tracts to the west.




