Dear Mr. Lowe,

Pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13(C)-(D) NMAC and the applicable rules governing the acreage and well location requirements for the WC-025 G-08 S263412K; Bone Spring (Pool Code 96672), Titus Oil & Gas Production, LLC ("Titus") requests administrative approval of a non-standard location for the above-referenced well, as described more fully below.

Standard setback for the first take point of a horizontal oil well is 100 feet from the outer boundary of the spacing unit. The above-referenced well, however, will be 1 foot from the outer boundary of the spacing unit. The affected tract will be the NE4 SW4 Sec. 17, T26S-R35E, Lea Co., NM. Titus is requesting approval to decrease the setback for the first take point of the above-referenced well as indicated below.

The proposed surface and bottom hole locations and first and last take points are as follows:

1. SHL: 1818' FSL and 2050' FWL of Sec. 17, T26S-R35E
2. FTP: 2640' FNL and 2310' FWL of Sec. 17, T26S-R35E
3. LTP: 100' FNL and 2310' FWL of Sec. 8, T26S-R35E
4. BHL: 10' FNL and 2310' FWL of Sec. 8, T26S-R35E

It is Titus' responsibility as a prudent operator to maximize the recovery of oil and gas reserves left in the ground. Approval of the unorthodox, completed interval will allow Titus to use its preferred well spacing plan for horizontal wells in this area and thereby maximize recovery and prevent waste.

Attached is the certified C-102 form and plat to assist the Division in its review of Titus's requests. Titus has sent notice to all affected persons on the enclosed spreadsheet by certified mail with a copy of this request, the plat, and the draft C-102. I attach a sample of the notice letter and a spreadsheet with the types of interests and names of the affected parties, the location of each parties' interest, the date the letter was sent, and the mail tracking number for the mailings that went out today.




