The OCD is in receipt of the timely extension request to commence injection on the aforementioned well. This correspondence will be added to the well file in order to document the process.

As the request is timely and the reasoning for the request is legitimate and acceptable, the request will be granted. Please to notify the OCD the date of first injection using the appropriate C-103. Remember, a witnessed MIT must be performed prior to injection. Additionally, be sure to file all completion paperwork within 45 days of commencing injection. I noticed that there are no spud, or other drilling NOIs currently in the file.

If injection has not commenced by the first of the year (01/01/2023), Longfellow should file a formal extension request including and updated AOR analysis for penetrations and new affected parties.
