Centennial Resource Production, LLC (OGRID No. 372165), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC and applicable rules governing acreage and well location requirements for the Red Hills; Bone Spring, North pool [96434], seeks administrative approval of an unorthodox well location for its **Juliet Fed Com #313H well** (API No. 30-025-50264), in a 240-acre, more or less, spacing unit underlying the E/2 NW/4 of Section 27 and the E/2 W/2 of Section 22, T24S, R34E, Lea County, New Mexico.

The proposed location is as follows:

- Surface location: 2338’ FNL and 540’ FWL (Unit E) of Section 27
- First take point: 2539’ FNL and 1387’ FWL (Unit F) of Section 27
- Last take point: 100’ FNL and 1394’ FWL (Unit C) of Section 22
- Bottom hole location: 100’ FNL and 1394’ FWL (Unit C) of Section 22

Since this acreage is governed by the Division’s statewide rules, the completed interval for this well will be unorthodox because it is closer than the standard offsets to the western boundary of the spacing unit – thus encroaching on the W/2 NW/4 of Section 27 and the W/2 W/2 of Section 22, T24S, R34E. As explained in the engineering statement included as **Exhibit A**, approval of

the unorthodox, completed interval will allow Centennial to use its preferred well spacing plan for horizontal wells in this area, which will maximize recovery and prevent waste.

**Exhibit B** is a Form C-102 showing the proposed Juliet Fed Com #313H well encroaches on the spacing unit/tracts to the west in the W/2 NW/4 of Section 27 and the W/2 W/2 of Section 22, T24S, R34E.

**Exhibit C** is a plat for the N/2 of Section 27 and all of Section 22, T24S, R34E, that shows the proposed Juliet Fed Com #313H well in relation to the adjoining spacing unit/tracts to the west. Exhibit C also includes an ownership list for the affected spacing unit to the west, showing that it is owned by Centennial Resource Production, LLC, Oxy USA, Inc., MRC Permian Company, COG Operating, LLC, Tap Rock Resources, II, LLC, Marathon Oil Permian, LLC, Novo Oil and Gas Northern Delaware, LLC and Chief Capital (O&G) II, LLC, as the working interest owners. In addition, the exhibit identifies that this includes a Bureau of Land Management (“BLM”) lease. Accordingly, the “affected persons”<sup>1</sup> are the applicant, Oxy USA, Inc., MRC Permian Company, COG Operating, LLC, Tap Rock Resources, II, LLC, Marathon Oil Permian, LLC, Novo Oil and Gas Northern Delaware, LLC, Chief Capital (O&G) II, LLC, and the BLM.

To Whom it May Concern,

Centennial Resource Production, LLC respectfully requests administrative approval on a non-standard location for the Juliet Fed Com #313H to allow the completed interval to be less than 330 feet from the western boundary of the existing 240-acre horizontal spacing unit. This well is located in the Red Hills; Bone Spring, North pool (96434). Due to the current spacing of the producing wells in this section, Centennial has planned the Juliet Fed Com #312H, Juliet Fed Com #313H, Solomon Fed Com #304H, Sheba Fed Com 305H and Sheba Fed Com #306H wells with at least 890 feet of spacing between each well. This spacing pattern causes the Juliet Fed Com #313H to be drilled less than 330 feet from the western boundary of the spacing unit. Centennial requests approval of this non-standard location to avoid causing wasted resources and reducing the production of the wells listed above.




