Pursuant to Division Rule No. 19.15.15.13 NMAC, Maverick Permian, LLC ("Maverick") respectfully requests administrative approval of an unorthodox oil well location for its Peridot 8 Federal Well No. 6H. This well will be drilled as a horizontal development oil well in the Maljamar; Yeso, West Pool (44500).

The Maljamar; Yeso West Pool is currently governed by Division Rule No. 19.15.15.9 which requires standard 40-acre oil spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit. In addition, since the subject well is a horizontal well, it is also governed by Division Rule No. 19.15.16.15 (C), which states that the distance in the horizontal plane from any point in the completed interval to any outer boundary of the horizontal spacing unit, measured along a line perpendicular to the completed interval, or to the tangent thereof, shall be a minimum of 330 feet for an oil well. This rule also allows the first and last take points of a horizontal well to be located no closer than 100 feet to any outer boundary of the spacing unit.

The proposed 481.92-acre standard horizontal spacing unit will comprise the N/2 of Section 7 and the NW/4 of Section 8, Township 17 South, Range 32 East, NMPM. This unit will ultimately be dedicated to the subject Peridot 8 Federal Well No. 6H, and to the proposed Peridot 8 Federal Wells No. 5H, 4H, 15H and 16H, all as shown on the attached plats and spreadsheet.

The proposed unorthodox well location is necessary in order to optimize the distance between the horizontal wells in the spacing unit, thereby increasing the recovery of oil and gas reserves from the Maljamar; Yeso, West Pool, and to avoid existing wells in the horizontal spacing unit.

Pursuant to Division Rules No. 19.15.15.13, 19.15.16.15 (C)(6) and 19.15.4.12, notice of the proposed unorthodox well location must be provided to affected offset operators, leasehold owners or owners of working interest. The affected offset acreage is identified as a proposed 481.80-acre horizontal spacing unit comprising the S/2 of Section 6 and SW/4 of Section 5, Township 17 South, Range 32 East, NMPM. This unit will be dedicated to the Peridot 5 Federal Well No. 7H, 8H and 18H, and to the Peridot 8 Federal Well No. 17H, and is operated by Maverick.

The affected 481.80-acre horizontal spacing unit is operated by Maverick, who owns 98% of the working interest in this unit. The remaining 2% working interest is owned by Chase Oil Corporation. Pursuant to Division Rule 19.15.2.7 (a)(8), which defines "Affected Persons", notice of this application is being provided to Chase Oil Corporation, being the only other working interest owner in the affected offset acreage.

A copy of this application is also being furnished to the United States Bureau of Land Management.

Included in this application are the following:

1. Form C-102 for the Peridot 8 Federal No. 6H;
2. Plat showing the proposed unit and affected offset acreage;
3. Spreadsheet showing wells, FTP and LTP locations for all wells in the proposed unit and affected offset unit;
4. Plat showing proposed development of the subject unit;
5. Standard Planning Report for the Peridot 8 Federal No. 6H; and
6. Proof of notice to Chase Oil Corporation.

In summary, approval of the application will provide Maverick the opportunity to recover additional oil and gas reserves from the Maljamar; Yeso, West Pool underlying the N/2 of Section 7 and NW/4 of Section 8, Township 17 South, Range 32 East, NMPM, that may otherwise not be recovered, thereby preventing waste, and will not violate correlative rights.
