Devon Energy Production Company, L.P., (“Devon”), OGRID No. 6137, is seeking administrative approval of an unorthodox well location (“NSL”) for the Spud Muffin 31-30 234H Well (the “234H Well”) (API 30-015-47571) to be completed within the Cedar Canyon; Bone Spring (Oil) Pool (Pool Code 11520) underlying the E/2 W/2 & W/2 E/2 of Sections 30 and 31, Township 23 South, Range 29 East, NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Location (SL): Located in Section 31-T23S-R29E: 775’ from the South line and 1815’ from the East line of said Section.
- Bottom Hole Location (BHL): Located in Section 30-T23S-R29E: 20’ from the North line and 1340’ from the East line of said Section.
- First Take Point (FTP): Located in Section 31-T23S-R29E: 100’ from the South line and 1340’ from the East line of said Section.
- Last Take Point (LTP): Located in Section 30-T23S-R29E: 100’ from the North line and 1340’ from the East line of said Section.

Devon has included as Exhibit B, a letter explaining why this application is needed. This well will produce from the Cedar Canyon; Bone Spring Pool (Pool Code 11520). The completed interval for the proposed well is closer than 330' from the East boundary of the spacing unit.

The unorthodox location will encroach towards the East boundary of the spacing unit.

Devon attests that, on or before submission of this application, it provided notice to the parties affected by the non-standard location; said notice as described satisfies all provisions of NMAC 19.15.4.12A(2); copies of the application and required plat maps were furnished. Devon provides herein a sectional map of this area, attached as Exhibit C. Proof of mailing, along with a copy of the notice letter sent to listed affected persons and parties, is attached hereto as Exhibit D. The development plan that includes this well had been originally initiated pursuant to pooling application in Case No. 16449.



Devon Energy Production Company, LP ("Devon") respectfully requests administrative approval of a non-standard location for the Spud Muffin 31-30 234H (the "Well") referenced above. The Well is in the Cedar Canyon; Bone Spring Pool (Pool Code 11520) with first and last take points at roughly 1,340' FEL, in between approved Bone Spring horizontal spacing units. Devon's responsibility as a prudent operator is to minimize reserves left in the ground. Decreasing the perpendicular setback from 330' will allow for tighter well spacing, thereby increasing the ultimate recovery of reserves and thereby preventing the waste of natural resources.


