Permian Resources Operating, LLC (“Permian”) (OGRID No. 372165), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC and applicable rules governing acreage and well location requirements for the Ojo Chiso; Bone Spring [Pool Code 96553], seeks administrative approval of an unorthodox well location for its **Eric Cartman 31 State Com #505H well** (API No. 30-025-50160), in a 160-acre, more or less, spacing unit underlying the W/2 E/2 of Section 31, Township 21 South, Range 35 East, Lea County, New Mexico.

The location for the **Eric Cartman 31 State Com #505H oil well** is as follows:

- Surface hole location: 135’ FNL and 415’ FEL (Unit A) of Section 31
- First take point: 100’ FNL and 1,330’ FEL (Unit B) of Section 31
- Last take point: 100’ FSL and 1,330’ FEL (Unit O) of Section 31
- Bottom hole location: 100’ FSL and 1,330’ FEL (Unit O) of Section 31

Since this acreage is governed by the Division’s statewide rules, the completed interval for this well will be unorthodox because it is closer than the standard offsets to the eastern boundary of

the spacing unit—thus, encroaching on the proposed¹ Eric Cartman 31 State Com #506H well spacing unit in the E/2 E/2 of Section 31, T21S-R35E, and the E/2 E/2 of Section 6 and the E/2 NE/4 of Section 7, T22S-R35E, NMPM, Lea County, New Mexico. As explained in the engineering statement included as **Exhibit A**, approval of the unorthodox, completed interval is necessary to allow Permian to use its preferred well spacing plan for horizontal wells in this area, which will maximize recovery and prevent waste.

Exhibit B is a Form C-102 showing the Eric Cartman 31 State Com #505H well encroaches on the tracts to the east in the E/2 E/2 of Section 31.

Exhibit C is a plat for Section 31, T21S-R35E, and Section 6 and the N/2 of Section 7, T22S-R35E, that shows the Eric Cartman 31 State Com #505H well in relation to the adjoining tracts/proposed spacing unit to the east. The proposed designated operator of the offsetting unit is Permian, which also includes the following other working interest owners: Chevron Midcontinent, L.P, Fuel Products, Inc., Gahr Energy Company, Mark K. Nearburg, and MRC Permian Company. In addition, the exhibit identifies that this includes New Mexico State Land Office (“SLO”) leases. Accordingly, the “affected persons”² are Permian, the other working interest owners, and the SLO.

Exhibit D is a spreadsheet listing all affected persons and includes tracking information demonstrating that each of the affected persons requiring notice was sent a copy of this application with all attachments by certified mail advising that any objections must be filed in writing with the Division within 20 days from the date the Division receives the application. 

To Whom it May Concern,

Permian Resources Operating, LLC ("Permian") respectfully requests administrative approval on a non-standard location for the Eric Cartman 31 State Com #505H to allow the completed interval to be less than 330 feet from the eastern boundary of the existing 160-acre horizontal spacing unit. This well is located in the Ojo Chiso; Bone Spring pool (96553). Due to the current spacing of the producing wells in this section, Permian has planned the Eric Cartman 6 State Com #501H, Eric Cartman 6 State Com #502H, Eric Cartman 31 State Com #504H and Eric Cartman 31 State Com #506H wells with at least 1,000 feet of spacing between each well located in the East half of said section. This spacing pattern causes the Eric Cartman State Com #505H to be drilled less than 330 feet from the eastern boundary of the spacing unit. Permian requests approval of this non-standard location to avoid causing wasted resources and reducing the production of the wells listed above.




