Fatma:

It is not a matter of what OCD prefers. The selection and approval of injection intervals are based on the availability for the operator's needs, the requirements of the federal UIC program under the SDWA and the obligations detailed in the New Mexico OII and Gas Act. In the Delaware Basin portion of the Permian, the selection of Devonian was in response to shallow disposal injection which was creating both drilling issues for completion in the deeper productive formations and flooding of producing wells. North of the Basin towards the slope and shelf, injection into the San Andres and the Upper Penn – Cisco/Canyon – has been successful. But these disposal intervals have their own issues of limited volume/rate and the higher occurrences of shallower USDW.

As to the Dagger Draw area, many of the deep disposal wells were drilled when the stratigraphic correlations in the area were not as developed as they are now. This also is a period in the history of oil and gas development when "induced seismicity" was thought not possible and was not accepted as possible lability associated with significant growth in produced water disposal.

So, Cisco/Canyon always has potential. There is even opportunity for "revitalizing" deeper disposal but with conditions such as limited rates and plugback of deep wells to isolate any communication with the Precambrian. However, there remains difficulties in the Dagger Draw area due the multitude of operators and the observation that injection sources and resulting EQ events can be offset by significant distance (Dr. Litherland's RISC presentation).
