

Just as a bit of background, the State 19 #2 SWD application was previously approved on April 1, 2021, and due to circumstances beyond V-F's control (Letter attached details events), V-F was unable to meet its April 1, 2022 disposal date. Since April 1, 2021 to today's date, there has not been any material change in this area and the State 19 #2 SWD is fully equipped and ready to accept water. V-F is in the process of flowing back 6 horizontal wells and would like to be able to utilize this SWD for its operations.

As such I have the following questions:

- Is V-F able to utilize the State 19 #2 SWD for its own on lease disposal as it currently stands?
- Being that this application has essentially already been approve, how long approximately is the administrative review process in these kinds of situations?
- Is there anything else V-F needs to do during or any other documents V-F needs to file during the administrative review process?
