You have requested to complete this horizontal well as a gas well described above in the referenced pool or formation. This well is governed by special rules, R-14262, for the Purple Sage; Wolfcamp (Gas) Pool and provides for 320-acre units, with wells located at least 330 feet from a unit outer boundary.

This well's completed interval is as close as 100 feet to the southern and northern boundary of the horizontal spacing unit. Encroachment will impact the following tract.

Section 11, T24S, R29E encroachment to the NW/4
Section 35, T23S, R29E encroachment to the SW/4

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in Paragraph (8) Subsection A of 19.15.2.7 NMAC, in all adjoining units towards which the proposed location encroaches.

Division understands you are seeking this unorthodox location to minimize reserves left in the ground of horizontal wells intended for this location and thereby preventing waste within the Wolfcamp formation underlying the W/2 of Section 02, T24S, R29E and the W/2 of Section 35, T23S, R29E.

Your application has been filed under 19.15.16.15(C)(6) NMAC, 19.15.15.13 NMAC and 19.15.4.12 (A)(2) NMAC.
