Devon Energy Production Company, L.P., (“Devon”), OGRID No. 6137, is seeking administrative approval of unorthodox well location (“NSL”) for the Van Doo Dah 33-28 Fed Com 834H Well (API 30-015-pending) to be completed within the WC-025 S253227A;LWR Wolfcamp Gas (Pool Code 98203) underlying the E/2 of Section 33, Township 25 South, Range 32 East, NMPM, Lea County, New Mexico, and the E/2 of Section 28, Township 25 South, Range 32 East, NMPM, Lea County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Location (SL): 177’ from the South line and 881’ from the East line of Section 33, Township 25 South, Range 32 East;
- Bottom Hole Location (BHL): 20’ from the North line and 990’ from the East line of Section 28, Township 25 South, Range 32 East;
- First Take Point (FTP): 100’ from the South line and 990’ from the East line of Section 33, Township 25 South, Range 32 East;
- Last Take Point (LTP): 100’ from the North line and 990’ from the East line of Section 28, Township 25 South, Range 32 East.

Devon has included as Exhibit B, a letter explaining why this application is needed. This well will produce from the WC-025 S253227A;LWR Wolfcamp Gas Pool (Pool Code 98203).

The unorthodox location will encroach towards the (1) E/2 of Section 4, Township 26 South, Range 32 East, NMPM, Lea County, New Mexico, and the (2) E/2 of Section 21, Township 25 South, Range 32 East, NMPM, Lea County, New Mexico.

Devon attests that, on or before submission of this application, it provided notice to the affected persons in the adjoining E/2 of Section 4, Township 26 South, Range 32 East NMPM, Lea County, New Mexico; however the interest which the well encroaches toward the E/2 of Section 21, Township 25 South, Range 32 East is owned 100% by Devon, so no notice is required; said notice as described satisfies all provisions of NMAC 19.15.4.12A(2); copies of the application and required plat maps were furnished. Devon also provided notice to the Bureau of Land Management to the extent that they own interest with respect to offsetting areas. Devon provides herein a sectional map of this area, attached as Exhibit C. Proof of mailing, along with a copy of the notice letter sent to listed affected persons and parties, is attached hereto as Exhibit D. There is no compulsory pooling case associated with this well.

Devon Energy Production Company, L.P. respectfully requests administrative approval of a non-standard location for the Well referenced above. The Well is in the Lower Wolfcamp Gas Pool (Pool Code 98203). It is Devon's responsibility as a prudent operator to minimize reserves left in the ground. Decreasing the first and last take point from three hundred and thirty feet (330') to one hundred feet (100') will increase the wells effective lateral length by 460 feet thereby increasing ultimate recovery of reserves and thereby preventing waste of natural resources.


