Dear Mr. Lowe:

Pursuant to Division Rule 19.15.15.13, Mewbourne Oil Company (“Mewbourne”) respectfully requests administrative approval of unorthodox gas well locations for the above captioned TOMMY BOY 23/24 W0MP FEE #1H well. This well will be drilled as horizontal gas well in the Purple Sage Wolfcamp (Gas) Pool (98220).

The above well will be dedicated to a standard 640-acre gas spacing and proration unit comprising the S/2 of Section 23 and the S/2 of Section 24.

The Purple Sage Wolfcamp (Gas) Pool is currently governed by Special Pool Rules, Hearing Order No. R-14262 which requires standard 320-acre gas spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit, nor closer than 10 feet to any interior quarter-quarter section line or subdivision inner boundary, or in the case of a horizontal well, no closer than 330 feet to the outer boundary of the producing area.

The unorthodox locations are necessary in order to maximize the recovery of oil and gas reserves from the Wolfcamp formation underlying the S/2 of Section 23 and the S/2 of Section 24.

The affected offset acreage comprises the SE/4 of Section 22, T22S, R27E, NMPM for the unorthodox first take-point location and the SW/4 of Section 19, T22S, R28E, NMPM for the unorthodox last take-point location (See Attached Map). Both offset acreage locations are operated by Mewbourne Oil Company.

Attached is our Form C-102 showing the surface, first take point, and bottomhole location for the above captioned well. Also, attached is a map showing the affected offset acreage, a horizontal well plan, and notice list.

In summary, approval of the application will provide Mewbourne Oil Company the opportunity to recover additional oil and gas reserves from the Purple Sage Wolfcamp (Gas) Pool underlying Sections 23 & 24 that may otherwise not be recovered, thereby preventing waste, and will not violate correlative rights.


