WPX Energy Permian, LLC (“WPX”) (OGRID No. 246289), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC and applicable rules governing acreage and well location requirements for the Purple Sage; Wolfcamp (gas) Pool [98220], seeks administrative approval of an unorthodox well location for its **Steel Guitar 35-26 Fed Com 412H** well (API No. 30-015-49850), in a 431.99-acre, more or less, spacing unit underlying the W/2 of Section 26 and the W/2 of irregular Section 35, T26S-R29E, Eddy County, New Mexico.

The proposed location for the **Steel Guitar 35-26 Fed Com 412H** well is as follows:

- Surface location: 434’ FNL and 1,897’ FWL (Unit C) of Section 26
- First take point: 100’ FNL and 1,470’ FWL (Unit C) of Section 26
- Last take point: 1,749’ FNL and 1,470’ FWL (Lot 10) of irregular Section 35
- Bottom location: 1,799’ FNL and 1,470’ FWL (Lot 10) of irregular Section 35

Since this acreage is governed by the Division’s Special Pool Rules, the completed first and last take points will be unorthodox because each is closer than the allowable offsets to the north and south boundary of the spacing unit; thus, encroaching on the W/2 of Section 23, T26S-R29E and the acreage across the Texas border. As explained in the engineering statement included as **Exhibit A**, approval of the unorthodox, completed first and last take points is necessary to allow WPX to maximize recovery and prevent waste.

**Exhibit B** is a Form C-102 showing the Steel Guitar 35-26 Fed Com 412H well encroaches on the spacing unit/tracts to the north in the W/2 of Section 23, T26S-R29E, and the acreage to the south, across the Texas border.

**Exhibit C** is a plat for Section 23, 26, and 35, T26S-R29E, and Blk 57 T1, T&P RR Co. Svy, Loving Co., Texas, that shows the proposed Steel Guitar 35-26 Fed Com 412H well in relation to the adjoining spacing unit/tracts to the north and south. Exhibit C also includes an ownership list for the affected spacing unit/tracts to the north (Tract 1), showing that it is operated by Mewbourne Oil Company, as well as the spacing unit/tracts to the south (Tract 3), across the Texas border, showing that it is operated by BPX Operating Company and Mewbourne Oil Company. In addition, the exhibit identifies that Tract 1 includes a Federal lease. Accordingly, the “affected persons”<sup>1</sup> are Mewbourne Oil Company, BPX Operating Company, and the Bureau of Land Management. Lastly, this exhibit includes a signed cooperation agreement between WPX and Mewbourne Oil Company, mutually agreeing to waive protest so long as the first or last take point of any well is no closer than 100 feet from the lands described therein.

**Exhibit D** is a spreadsheet listing all affected persons and includes tracking information demonstrating that each of the affected persons was sent a copy of this application with all attachments by certified mail advising that any objections must be filed in writing with the Division within 20 days from the date the Division receives the application. 
