**Re: Report for El Paso Natural Gas Company's 120-day Temporary Discharge Permit No. HBP-NM-44**


El Paso Natural Gas Company (EPNG) is submitting the following report as requested in EPNG's 120-day Temporary Permit (Permit No. HBP-44). The report summarizes each test of new pipe, with less than 25,000 gallons per hydrostatic test event that occurred between October 13, 2023 and January 31, 2024 (when the renewal permit was issued).

1. **Project Description:** EPNG replaced the Washington Ranch Line No. 0615 (WR-0615) located in Eddy County, New Mexico.
  - a) **Location:** Section 34, Township 25 south, Range 24 East;
  - b) **Date of the discharge** was October 20, 2023. The water was used as dust mitigation within the existing ROW;
  - c) **The volume of water** discharged was approximately 400 gallons;
  - d) **The source of the water** was from a municipal water supply from the City of Carlsbad.
2. **Project Description:** EPNG installed a Flow Control Valve and Over Pressure Protection on Line No. 3026 at Milepost 0 located in Lea County, New Mexico.
  - a) **Location:** Section 7, Township 26 South, Range 37 East;
  - b) **Date of the discharge** was November 7, 2023. The water was used as dust mitigation within the existing ROW;
  - c) **The volume of water** discharged was approximately 20,000 gallons;
  - d) **The source of the water** was from a municipal water supply from the City of Kermit.
3. **Project Description:** EPNG replaced and lowered a Segment of Line No. 1004 at the intersection of Highway 404, located in Dona Ana County, New Mexico. Due to a miscommunication, EPNG did not provide the 72 hour prior notification as stipulated in the permit. EPNG will take corrective actions including retraining, so that company personnel understand the 72 hour prior notification requirement.

- a) **Location:** Section 24, Township 26 South, Range 3 East;
- b) **Date of the discharge** was December 3, 2023. The water was discharged into a filter bag within an upland area within the project footprint;
- c) **The volume of water** discharged was approximately 6,000 gallons;
- d) **The source of the water** was from a municipal water supply from the Town of Anthony.
