Dear Acting Director Fuge:

Devon Energy Production Company, L.P., (“Devon”), OGRID No. 6137, is seeking administrative approval of an unorthodox well location (“NSL”) for the Atlatl 11-10 Fed Com 333H Well (the “333H Well”) (API No. Pending) to be completed within the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) underlying the S/2 of Sections 11 and 10, Township 22 South, Range 27 East NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Location (SL): 1815’ from the South line and 405’ from the East line (Unit I) of Section 11, Township 22 South, Range 27 East;
- Bottom Hole Location (BHL): 1320’ from the South line and 20’ from the West line (Unit M) of Section 10, Township 22 South, Range 27 East;
- First Take Point (FTP): 1320’ from the South line and 100’ from the East line (Unit I) of Section 11, Township 22 South, Range 27 East;
- Last Take Point (LTP): 1320’ from the South line and 100’ from the West line (Unit M) of Section 10, Township 22 South, Range 27 East.

Devon has included as Exhibit B, a letter explaining why this application is needed. This well will produce from the Purple Sage Wolfcamp Pool (Pool Code 98220). The special Division rules for the Purple Sage; Wolfcamp (Gas) Pool establish 330' foot setback requirements which are laid out in Order No. R-14262. The first and last take points for the proposed well are closer than 330' from the boundary of the spacing unit.

The unorthodox location will encroach towards the (1) SW/4 of Section 12, Township 22 South, Range 27 East; and (2) the SE/4 of Section 9, Township 22 South, Range 27 East.

Devon attests that, on or before submission of this application, it provided notice to the affected persons in the adjoining horizontal spacing unit which covers S/2 of Sections 9 and 8, Township 22 South, Range 27 East; said notice as described satisfies all provisions of NMAC 19.15.4.12A(2); copies of the application and required plat maps were furnished. Devon further attests it owns 100% of the minerals in the adjoining SW/4 of Section 12, Township 22 South, Range 27 East, which is not part of a larger unit therefore no notice is required; however, Devon is noticing the BLM to the extent federal leases are involved with the well. Devon provides herein a sectional map of this area, attached as Exhibit C. Proof of mailing, along with a copy of the notice letter sent to listed affected persons and parties, is attached hereto as Exhibit D. This unit had originally been pooled in Case No. 24079.



Devon Energy Production Company, LP ("Devon") respectfully requests administrative approval of non-standard locations for the Atlatl 11-10 Fed Com 333H (the "Well") referenced above. The Well is in the Purple Sage; Wolfcamp Pool (Pool Code 98220) with first and last take points planned at roughly 100' FEL and FWL, respectively. It is Devon's responsibility as a prudent operator to minimize reserves left in the ground. Decreasing the first and last tank points from 330' will allow for increase in potential completed horizontal lateral, thereby increasing the ultimate recovery of reserves and thereby preventing waste of natural resources.


