Dear Director Fuge:

Devon Energy Production Company, L.P., (“Devon”), OGRID No. 6137, is seeking administrative approval of an unorthodox well location (“NSL”) for the Mule 11-23 Fed Com 304H Well (the “304H Well”) (API 30-015-Pending) located in the Paduca; Bone Spring (Oil) Pool (Pool Code 96641) underlying a standard 720-acre, more or less, horizontal spacing unit comprised of the E/2 of Sections 11 and 14 and the N/2 NE/4 of Section 23, all in Township 25 South, Range 31 East, NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that has been drilled as follows:

- Surface Location (SL): 450’ from the North line and 966’ from the East line (Unit A) of Section 11, Township 25 South, Range 31 East;
- Bottom Hole Location (BHL): 1288’ from the North line and 2600’ from the East line (Unit B) of Section 23, Township 25 South, Range 31 East;
- First Take Point (FTP): 100’ from the North line and 2600’ from the East line (Unit B) of Section 11, Township 25 South, Range 31 East;
- Last Take Point (LTP): 1208’ from the North line and 2600’ from the East line (Unit B) of Section 23, Township 25 South, Range 31 East.

Devon has included as Exhibit B, a letter explaining why this application is needed. This well will produce from the Paduca; Bone Spring Pool (Pool Code 96641). The statewide rules require that the completed interval shall be no closer than a 330' perpendicular distance from the lateral to outer boundary of the horizontal spacing unit.

Because the perpendicular distance from the lateral is less than 330', the unorthodox location encroaches toward W/2 of Sections 11 and 14 and the N/2 NW/4 of Section 23, all in Township 25 South, Range 31 East, NMPM, Eddy County, New Mexico.

Devon attests that, on or before submission of this application, it provided notice to the affected persons/parties in the adjoining unit toward which the 304H well encroaches. Devon has also provided notice to the Bureau of Land Management ("BLM") to the extent that federal leases are involved, pursuant to NMAC 19.15.2.7A(8)(d); said notice as described satisfies all provisions of NMAC 19.15.4.12A(2); copies of the application and required plat maps were furnished. Devon provides herein a sectional map of this area, attached as Exhibit C. Proof of mailing, along with a copy of the notice letter sent to the affected persons, is attached hereto as Exhibit D. Devon has informed us that there is no pooling case associated with this application.





Devon Energy Production Company, L.P. respectfully requests administrative approval of a non-standard location ("NSL") for the Mule 11-23 Fed Com 304H well (the "Mule well") referenced above. The Mule well is in the Paduca; Bone Spring Pool (Pool Code 96641). It is Devon's responsibility as a prudent operator to minimize reserves left in the ground. In order to decrease between well spacing and thereby maximize ultimate recovery of reserves and thereby preventing waste of natural resources, Devon desires to drill the Mule well less than 330' from the western boundary of an E/2 horizontal spacing unit established by the drilling of the Mule 11-23 Fed Com 305H well.


