Good Day Roni

We are processing Oxy's PMX request for the subject well. To ensure completeness for the wellfile, and to facilitate the final review and processing of your request (tentatively PMX-351), the following technical concerns were noted and

require clarification. The purpose for requesting this clarification is to ensure all injection remains <u>within</u> the approved Grayberg-SanAndres (G-SA) unitized interval.

#### Overview of OXY's proposed procedure

- A. 7" Casing shoe is at 4298 ft, and currently has a cement plug from 4248 4348 ft to isolate the openhole (OH) section
- B. Oxy proposes to drill out the top 50 ft of the cement plug to have PBTD @ 7" shoe at 4298 ft.
  - a. OCD Comment While drilling out there will be some depth uncertainty, and potential to drill below the shoe and expose the OH section.
- C. After re-perforating, a 4000 gal 15% HCl acid treatment is planned.
  - a. OCD Comment High potential for acid to dissolve cement across the 7" shoe and communicate to the OH section from 4298 5073 ft.
  - b. OCD Comment No tops could be found in the Well file for the OH section, so I am uncertain if it is part of the approved G-SA interval.

#### Items for Oxy to clarify are as follows: Refer to snapshots below.

- 1. Please confirm whether the Openhole section (4298 ft 5073 ft) is part of the Unitized G-SA approved injection interval
- 2. If the openhole section (4298 5073 ft) is not part of the unitized interval, OCD requests the procedure be modified to mitigate the potential for injection outside of the approved G-SA interval.
