Devon Energy Production Company, LP, respectfully requests approval to downhole commingle the Red Lake Queen-Grayburg-San Andres (51300) and the Northeast Red Lake-Glorieta Yeso (96836) pursuant to 19.15.5.303 (C) 3 (b) Exceptions for wells located in pre-approved pools or areas.

This pool was pre-approved by Division order PC-1108.

The San Andres is perforated at 2892-3234' and the Yeso is perforated from 1892-2469'.

Average production from the SA is 3.52 oil and 2.6 gas. Average production from the Yeso is 6.58 oil and 9.4 gas.

The allocation method is by ratio of stabilized production. For the Yeso, oil is 65.1% and gas is 78.3%.

For the San Andres formation, oil is 34.9% and gas is 21.7%.

Commingle these two pools will not reduce the value of the total remaining production and the ownership between the two pools is identical.

The BLM has been notified of this filing.
