The general conditions of the approval states that:

"This Permit shall terminate one (1) year after the date of issuance if Permittee has not commenced injection into the Well, provided, however, that OCD may grant a single extension of no longer than one (1) year for good cause shown. Permittee shall submit a written request for an extension to OCD Engineering Bureau no later than thirty (30) days prior to the deadline for commencing injection."

Since Select Energy hasn't adhered to this condition of approval and the timing for requesting extension of time (EOT), OCD will not grant Select Energy an EOT.
