<p>Solaris Water Midstream, LLC, 907 Tradewinds Blvd, Midland, TX 79706, (OGRID# 331374), is filing Form C-108 (Application for Authorization to Inject) with the New Mexico Oil Conservation Division seeking administrative approval for commercial saltwater injection into its Sims 18 SWD #1. This will be a new well located 1,224' FNL & 1,301' FWL in Section 18 Township 20S Range 36E in Lea County, NM, which is approximately 8.4 miles southwest of Monument, NM. The purpose of the well is to inject produced water from permitted oil and gas wells in the area for commercial disposal into the Tansil, Yates, Seven Rivers & Queen formations at depths of 3,354' – 4,866' at a maximum surface injection pressure of 670 psi and a maximum injection rate of 25,000 barrels of water per day.</p> <p>Objections or requests for hearing must be filed with the New Mexico Oil Conservation Division within fifteen (15) days.
