Devon Energy Production Co., LP respectfully requests approval to downhole commingle the Red Lake Queen-Grayburg-San Andres (51300) and the Northeast Red Lake-Glorieta Yeso (96836) pursuant to 19.15.5.303 (C) 3 (b) Exceptions for wells located in preapproved pools or areas.

This pool was pre-approved by Division order PC-1108.

The San Andres is perforated at 2077-2420' and the Yeso is perforated from 2943-3215'.

Average production from the SA is 11 oil and 12 gas. Average production from the Yeso is 28 oil and 38 gas.

The allocation method is by ratio of stabilized production. For the Yeso, oil is 71.8% and gas is 76.0%.

For the San Andres formation, oil is 28.2% and gas is 24.0%.

Commingle these two pools will not reduce the value of the total remaining production and the ownership between the two pools is identical.

The BLM has been notified of this filing.
