You have requested to drill this horizontal well at an unorthodox well location described above in the referenced pool or formation. 19.15.16.15(B)(1)(a) NMAC governs this proposed well and provides that the operator shall dedicate to each horizontal **oil** well a standard horizontal spacing unit that comprises of one or more contiguous tracts that the horizontal well's completed interval penetrates, each of which consists of a governmental quarter - quarter section or equivalent. 19.15.16.15(C)(1)(a) NMAC governs the distance in the horizontal plane from any point in the completed interval to any outer boundary of the horizontal spacing unit, measured along a line perpendicular to the completed interval or to the tangent thereof, shall be a minimum of 330 feet for an **oil** well. 19.15.16.15(C)(1)(b) NMAC governs the first and last take point of a horizontal well shall be no closer than 100 feet in the horizontal plane, to any outer boundary of the horizontal spacing unit.

The request to deviate from an orthodox location has met all requirements of 19.15.16.15 (C)(5)(a) NMAC. It is understood that you are seeking this exception in order to create a non-standard location, comprised of Take Points referenced above, within the described Horizontal Spacing Unit. *This wells entire horizontal spacing unit comprises of two pools: (1) Sand Dunes; Bone Spring [53800] and (2) Sand Dunes; Bone Spring South [53805].* This NSL pertains to the latter portion of the producing spacing unit, Pool Code No. 53805.

This well's completed interval is as close as 200 feet to the eastern edge of the horizontal spacing unit. Encroachment will impact the following tracts.

Section 17, encroachment to the W/2 E/2

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in 19.15.2.7(A)(8) NMAC, in all adjoining units towards which the proposed location encroaches.

Devon Energy Production Company, L.P., ("Devon"), OGRID No. 6137, is seeking administrative approval of an unorthodox well location ("NSL") for the Exotic Cat 5-17 Fed Com 302H Well (the "302H Well") (API No. 30-025-53636) to be completed within the Sand Dunes; Bone Spring South Pool (Pool Code 53805) underlying a standard 479.52-acre unit comprised of Lot 3, the SE/4NW/4, and the E/2SW/4 (the E/2W/2 equivalent) of Section 5 and the E/2W/2 of Sections 8 and 17, all in Township 23 South, Range 32 East NMPM, Lea County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

Devon has included as Exhibit B, a letter explaining why this application is needed. This well will produce from the Sand Dunes; Bone Spring South Pool (Pool Code 53805). The statewide rules establish 330' foot perpendicular setback requirements for the completed interval. The completed interval for the proposed well will be closer than 330' from the boundary of the spacing unit.

The unorthodox location will encroach towards Lot 2, the SW/4NE/4, and the W/2SE/4 (the W/2E/2 equivalent) of Section 5 and the W/2E/2 of Sections 8 and 17, all in Township 23 South, Range 32 East.

Devon attests that, on or before submission of this application, it provided notice to the affected persons in the adjoining horizontal spacing unit which covers the W/2E/2 of Section 17, Township 23 South, Range 32 East.; said notice as described satisfies all provisions of 19.15.4.12A(2) NMAC; copies of the application and required plat maps were furnished.
