Dear Shelly Cowden,

Reference is made to your June 23, 2025, request on behalf of OWL SWD OPERATING, LLC, (the "operator") to extend the injection authority for the subject well which will expire July 1, 2025 due to a consecutive 12 months of inactivity to November 30, 2025.

The operator justified its extension request due to time needed to repair the casing issues and acquire necessary equipment to repair the holes in the casing and get the well back to injection.

The Division finds that for reasons you have stated, the granting of this request to extend this administrative order is in the interest of conservation, will prevent waste, and will protect the environment. Therefore, the deadline to commence injection for the existing order is hereby extended until November 30, 2025.

All requirements of the above-mentioned administrative order and agreements in the application remain in full force and effect. Any additional extension of the deadline to commence injection for this administrative order will not be considered unless the operator has already resumed injecting into the referenced well. Otherwise, the injection authority shall expire under the terms of the
