You have requested to complete this horizontal well described above in the referenced pool or formation. This well is governed by special rules R-14262, for the Purple Sage; Wolfcamp (Gas) Pool and governs wells to be located at least 330 feet from the unit outer boundary of a spacing unit and no closer than 10 feet to any quarter – quarter section line. The completed intervals of

horizontal wells are to be located no closer than 330 feet to the exterior boundary of a standard 320 - acre spacing unit.

The request to deviate from an orthodox location has met all requirements of 19.15.16.15 (C)(5)(a) NMAC. It is understood that you are seeking this exception in order to create a non-standard location, comprised of First and Last Take Points referenced above within the described Horizontal Spacing Unit.

The well's completed interval is as close as 100 feet to the northern boundary of the horizontal spacing unit. Encroachment will impact the following tract(s).

Section 23, encroachment to the SE/4

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in Paragraph (8) Subsection A of 19.15.2.7 NMAC, in all adjoining units towards which the proposed location encroaches.

Division understands you are seeking this unorthodox location for optimized well spacing and improving overall productivity of wells within the unit. Thus, preventing waste within the Wolfcamp formation underlying the E/2 Section 26 and E/2 Section 35, therefore protecting the correlative rights of all parties affected.

Your application has been filed under 19.15.16.15(C)(6) NMAC, 19.15.15.13 NMAC and 19.15.4.12 (A)(2) NMAC.

In accordance with Division Rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC, WPX Energy Permian, LLC (“WPX”), OGRID No. 246289, seeks administrative approval of an unorthodox well location (“NSL”) for the Steel Guitar 35-26 Fed Com 460H Well, underlying a standard 430.31-acre, more or less, horizontal spacing unit, comprised of the E/2 of Section 26 and Lots, 5, 6, 11 and 12 of Section 35, Township 26 South, Range 29 East, Eddy County, New Mexico.

The location for the proposed Steel Guitar 35-26 Fed Com 460H gas well is as follows:

- SL (Surface Location): 463’ FNL and 2,176’ FWL (Unit C), Section 26
- FTP (First Take Point): 100’ FNL and 2,000’ FEL (Unit B), Section 26
- LTP (Last Take Point): 100’ FSL and 2,000’ FEL (Lot 11), Section 35
- BHL (Bottom Hole Location): 1,782’ FNL and 2,000’ FEL (Lot 11), Section 35

The completed interval and the first and last take points of the proposed well will be unorthodox because they are located less than 330’ from the boundary of the spacing unit. As explained in the engineering statement, **Exhibit A**, approval of the non-standard location, is

WPX Energy Permian, LLC, a wholly owned subsidiary of Devon Energy Corporation, respectfully requests administrative approval of a nonstandard location for the Steel Guitar 35-26 Fed Com 460H and 470H. This well is in the Purple Sage-Wolfcamp Gas Pool (Pool Code 98220). It is WPX's responsibility as a prudent operator to minimize reserves left in the ground. 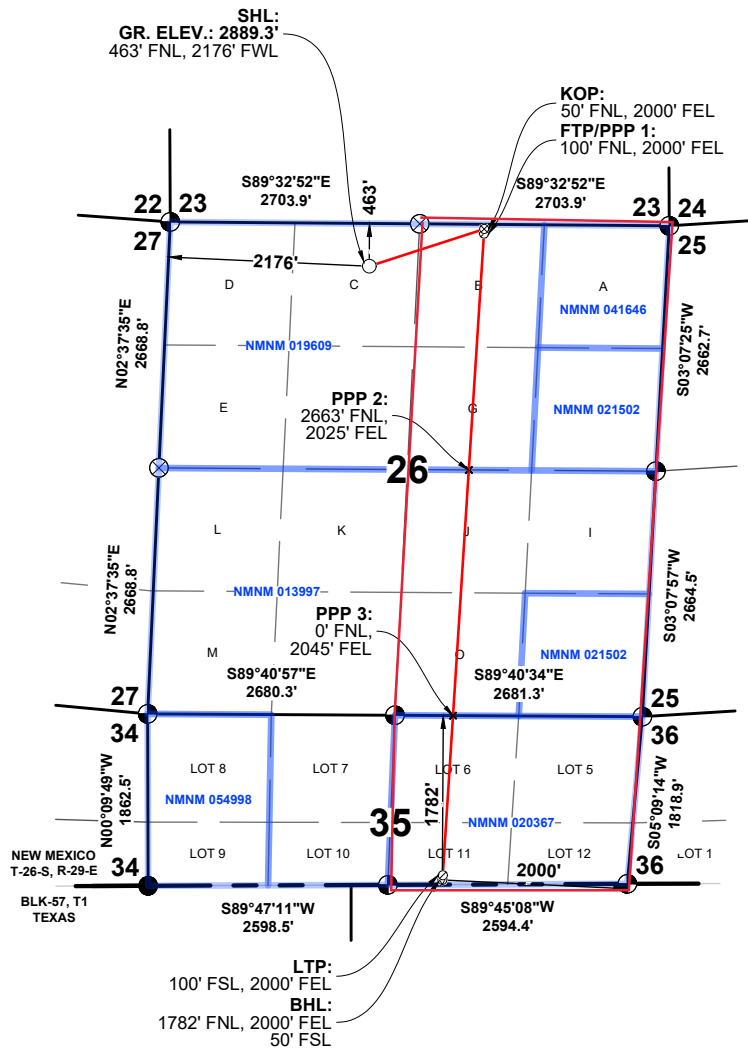

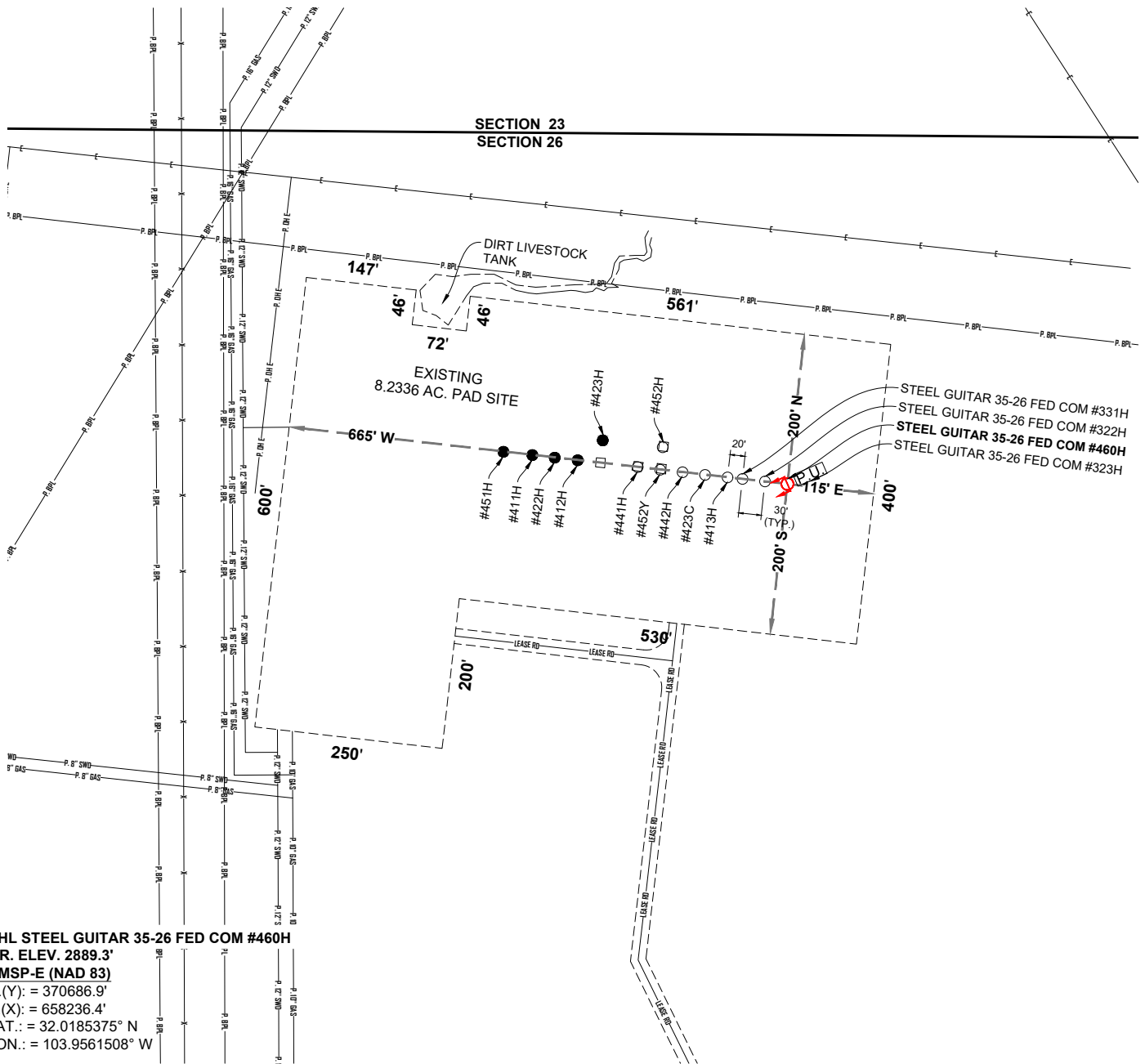

SITE LOCATION

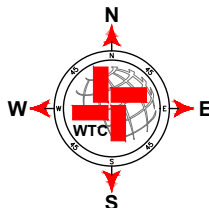

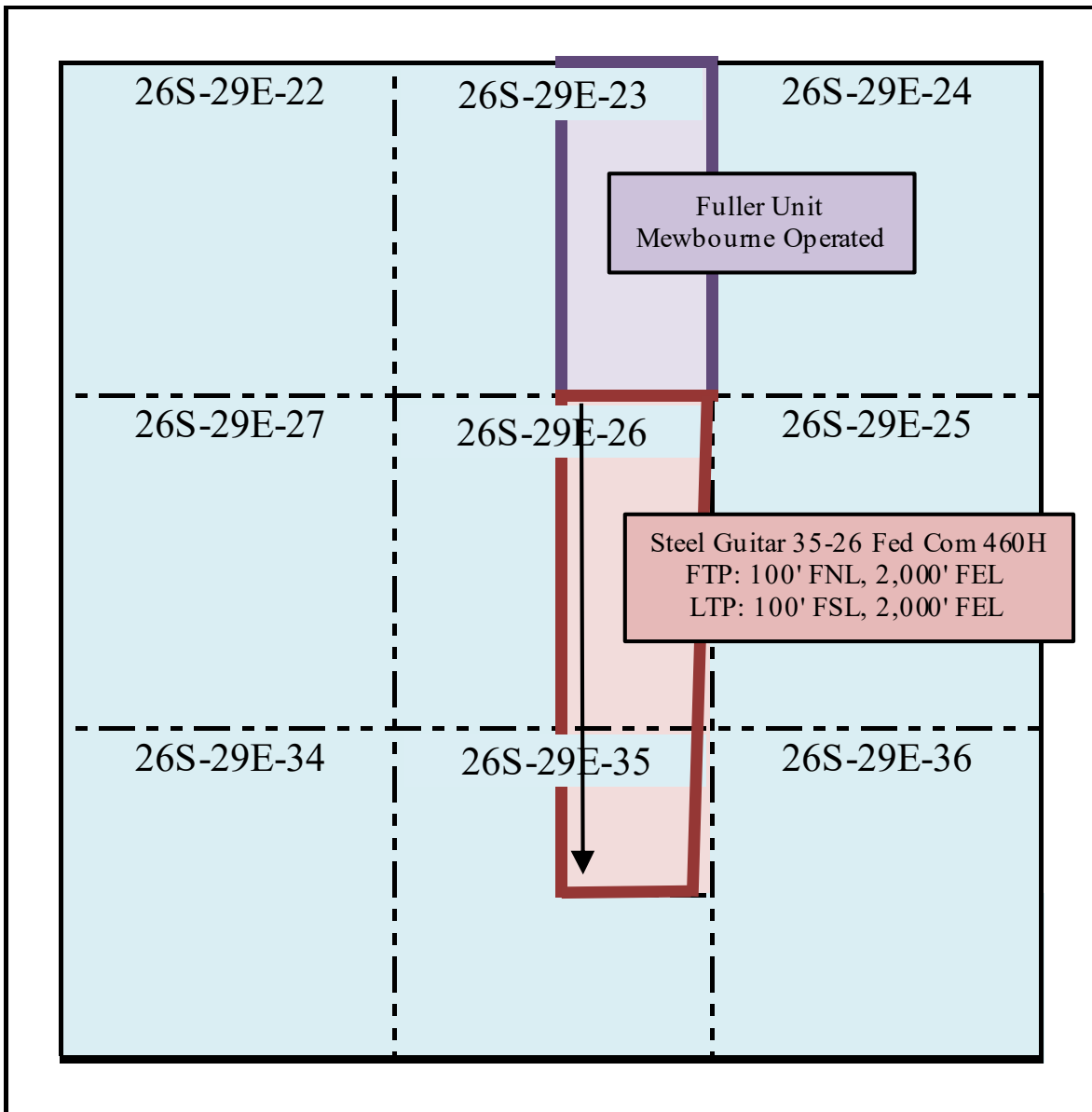
