**Re: WaterBridge Stateline LLC Request for Extension of Time to Commence Injection Operations Under Order R-23774/UIC Permit SWD-2648**

Dear Oil Conservation Division:

WaterBridge Stateline LLC (“WaterBridge”) respectfully requests a one (1) year extension to commence injection operations in the FPNM SWD No. 3 (the “Well”), under Order R-23774/UIC Permit SWD-2648 (the “Order”), through April 30, 2027. This extension is being requested because, while WaterBridge is currently drilling injection wells in and around this area, this Well is on the development schedule after the current set of wells are drilled, which will be after the deadline in the Order.

In further support of this request, WaterBridge states as follows:

1. The Order was issued to WaterBridge on April 30, 2025, and authorized WaterBridge to utilize the Well as an Underground Injection Control (“UIC”) Class II well for commercial disposal of produced water into the Glorieta Sandstone.
2. Pursuant to the Order, the Division issued WaterBridge a UIC Class II permit, Permit SWD-2648.
3. WaterBridge is requesting an extension of time pursuant to UIC Permit SWD-2648, which states: “This Permit shall terminate one (1) year after the date of issuances if Permittee has not commenced injection into the Well, provided, however, that PCD may grant a single extension of no longer than one (1) year for good cause shown. Permittee shall submit a written request for an extension to OCD Engineering Bureau no later than thirty (30) days prior to the deadline for commencing injection.” UIC Permit SWD-2648, § I.A.3(a).
4. Good cause exists for WaterBridge’s request for an extension of time.

5. WaterBridge applied for and received several injection permits for injection wells in Texas, which WaterBridge has been developing. WaterBridge currently has two rigs drilling in the Central Basin Platform area.
6. WaterBridge has a development plan for its injection wells in both New Mexico and Texas, which involves scheduled deployment of resources.
7. WaterBridge intends to drill and operate the Well as part of its overall development plan.
8. The Division entered Order R-23774 after a hearing held on June 27, 2024. WaterBridge submitted written and live testimony, as well as exhibits to support the application. No parties objected to WaterBridge's application.
9. At the hearing, the Division requested WaterBridge submit additional information and analysis in support of the application, which WaterBridge did on August 27, 2024.
10. The Division issued the Order in April 2025 after reviewing the initial and additional materials submitted by WaterBridge.
11. Both the Division and WaterBridge have devoted substantial resources to the Order and an extension of time is warranted for administrative efficiency to avoid unnecessary additional time and effort if the Order were to terminate.
12. WaterBridge has reviewed the one-half mile Area of Review (AOR) associated with this well and no new affected parties were identified and no additional wells penetrating the approved injection interval have been drilled. *See Exhibit A, Declaration of Reed Davis.*
13. WaterBridge's request for an extension of time to commence injection is timely because WaterBridge is submitting this request more than 30 days before the deadline to commence injection in the Order, which is April 30, 2026.
14. WaterBridge is also an active stakeholder in New Mexico and is committed to responsible development to address injection needs in New Mexico.

For these reasons, WaterBridge respectfully requests that R-23774 and UIC Permit SWD-2648f be amended to allow WaterBridge a one-year extension of time to commence injection into the Well, through April 30, 2027.

Good afternoon, Deana, and hopefully you also enjoyed a Thankful Day of Giving. The effective date remains unchanged – the April 30<sup>th</sup> date. The fact that the content posted was incomplete does not change the findings of the orders and the obligations. If the April 30<sup>th</sup> deadline is not feasible, an extension is available noting this event. This maybe necessary as the mineral estate for the FPAM wells is BLM and they typically will (but not necessarily) defer to the OCD for issuance of an APD where the well is new and not drilled for oil and gas E&P.
