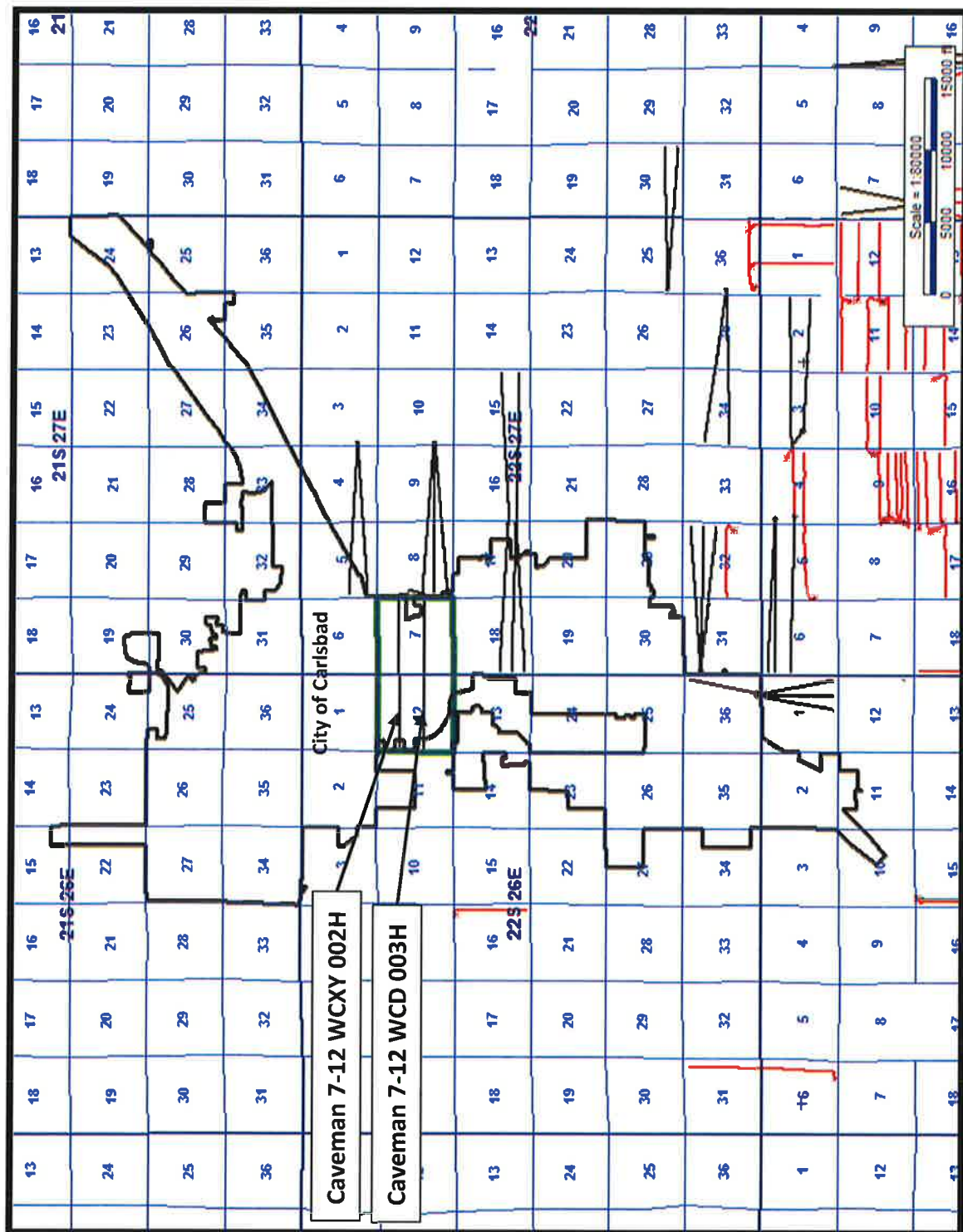

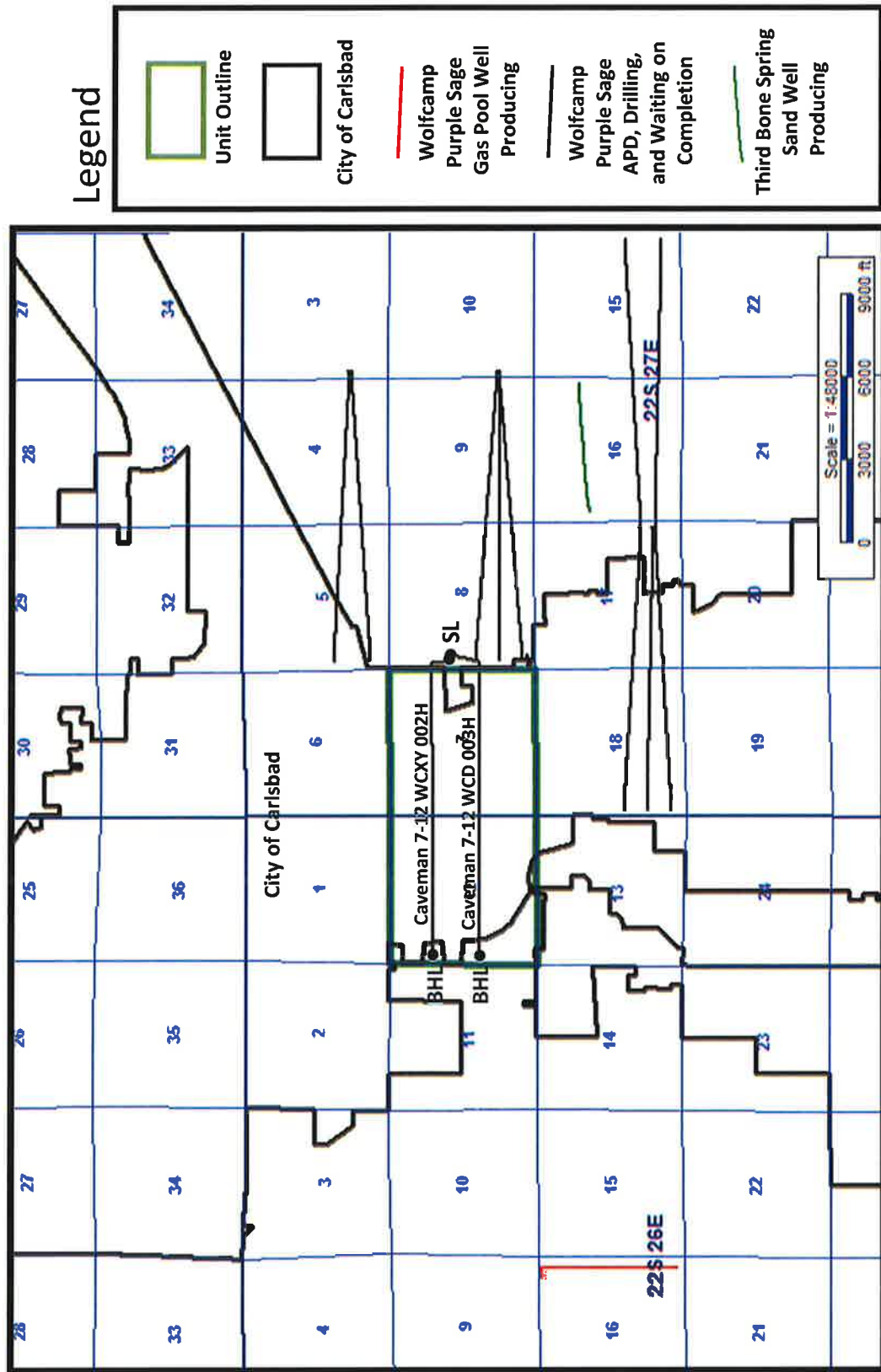
UNIT 7-12 PROJECT LOCATOR MAP

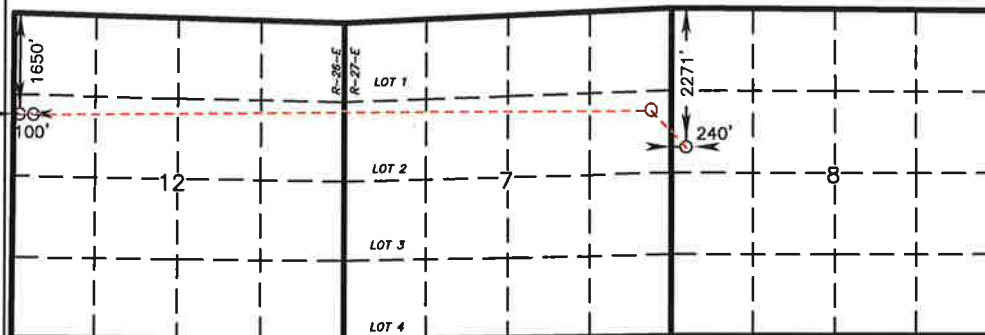

SPC Resources, LLC ("SPC") as Operator hereby proposes to form a 1280.00 acre (1267.10 actual gross acre) working interest unit to include all of *Section 7, Township 22 South Range 27 East* and all of *Section 12, Township 22 South Range 26 East* for oil and gas production. The targeted interval for the proposed unit is the Wolfcamp formation. SPC hereby proposes to drill and operate the following horizontal Wolfcamp wells:

1. **Caveman 7-12 WCXY #2H** located at a surface location 240 feet FWL and 2135 feet FNL of Section 8, T22S-R27E and a bottom hole location 100 feet FWL and 1650 feet FNL of Section 12, T22S-R26E. We anticipate drilling to an approximate total vertical depth of 8780 feet and plan to continue drilling horizontally to the west to the proposed bottom hole location at an approximate total measured depth of 19600 feet.
2. **Caveman 7-12 WCD #3H** located at a surface location 240 feet FWL and 2300 feet FSL of Section 8, T22S-R27E and a bottom hole location 100 feet FWL and 1980 feet FSL of Section 12, T22S-R26E. We anticipate drilling to an approximate total vertical depth of 9300 feet and plan to continue drilling horizontally to the west to the proposed bottom hole location at an approximate total measured depth of 20000 feet.

Regarding the above wells, enclosed for your further handling and information are copies of our Authorization for Expenditure ("AFE") for each well. Please be aware that the enclosed AFE is only an estimate of costs to be incurred and by electing to participate in the Well, each working interest owner shall be responsible for its proportionate share of all costs incurred.

Within thirty (30) days of receipt hereof, please return a copy of this letter indicating your election to participate or non-consent the drilling and completion of each well in the spaces provided below. Should you elect to participate, please also execute and return each respective AFE. Feel free to return your election paperwork via email to cbradley@santopetroleum.com or the letterhead address above in the enclosed self-addressed envelope.

Upon receipt of an election to participate, SPC will provide you with complete copy of the working interest unit Operating Agreement for your review. The Operating Agreement will have COPAS rates of \$8,000/month while drilling, \$800/month for a producing well and a non-consent penalty of 100%/300%/300%.

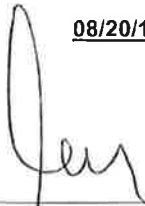

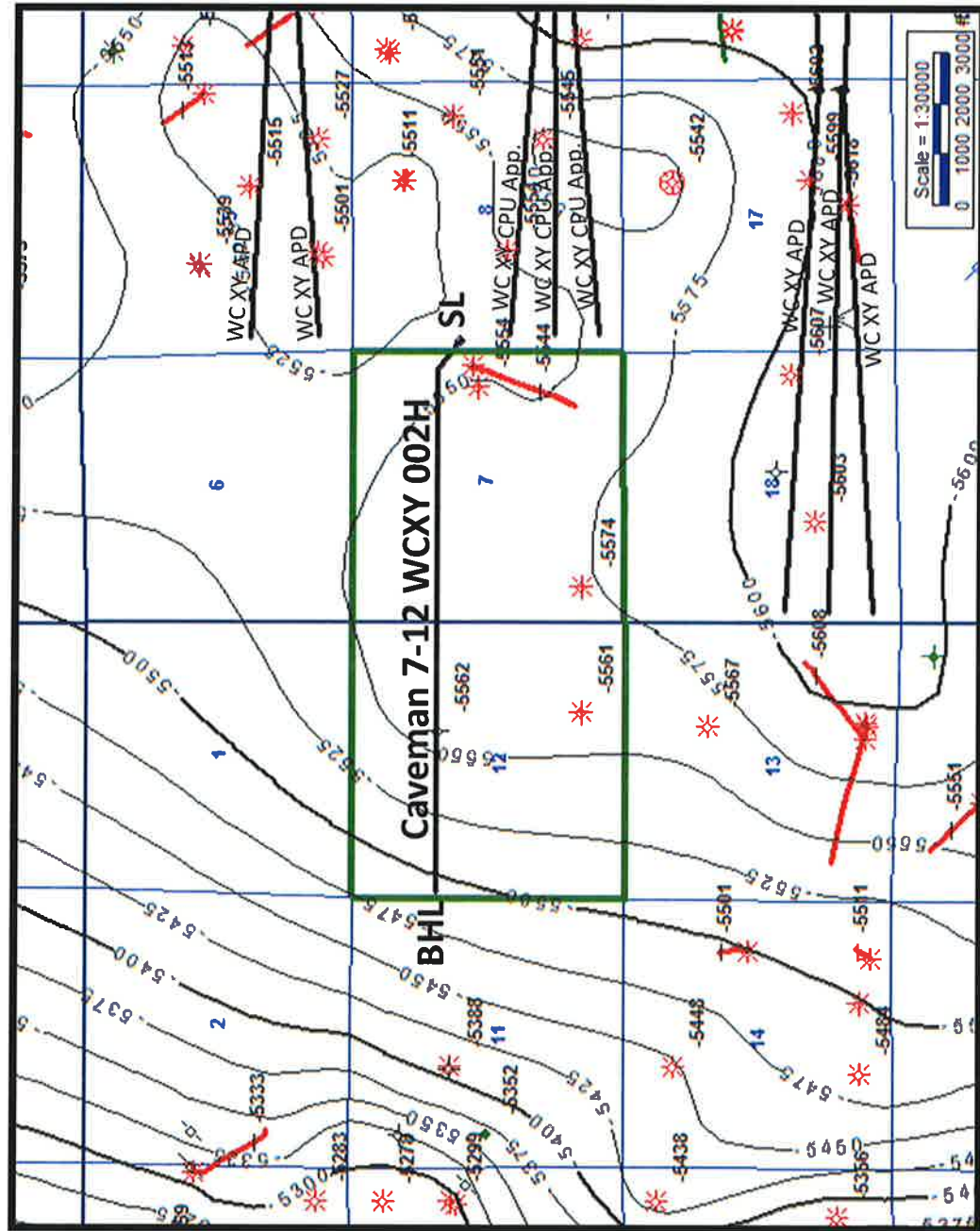

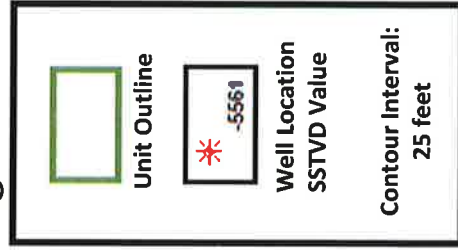

UNIT 7-12 WOLFCAMP A STRUCTURE



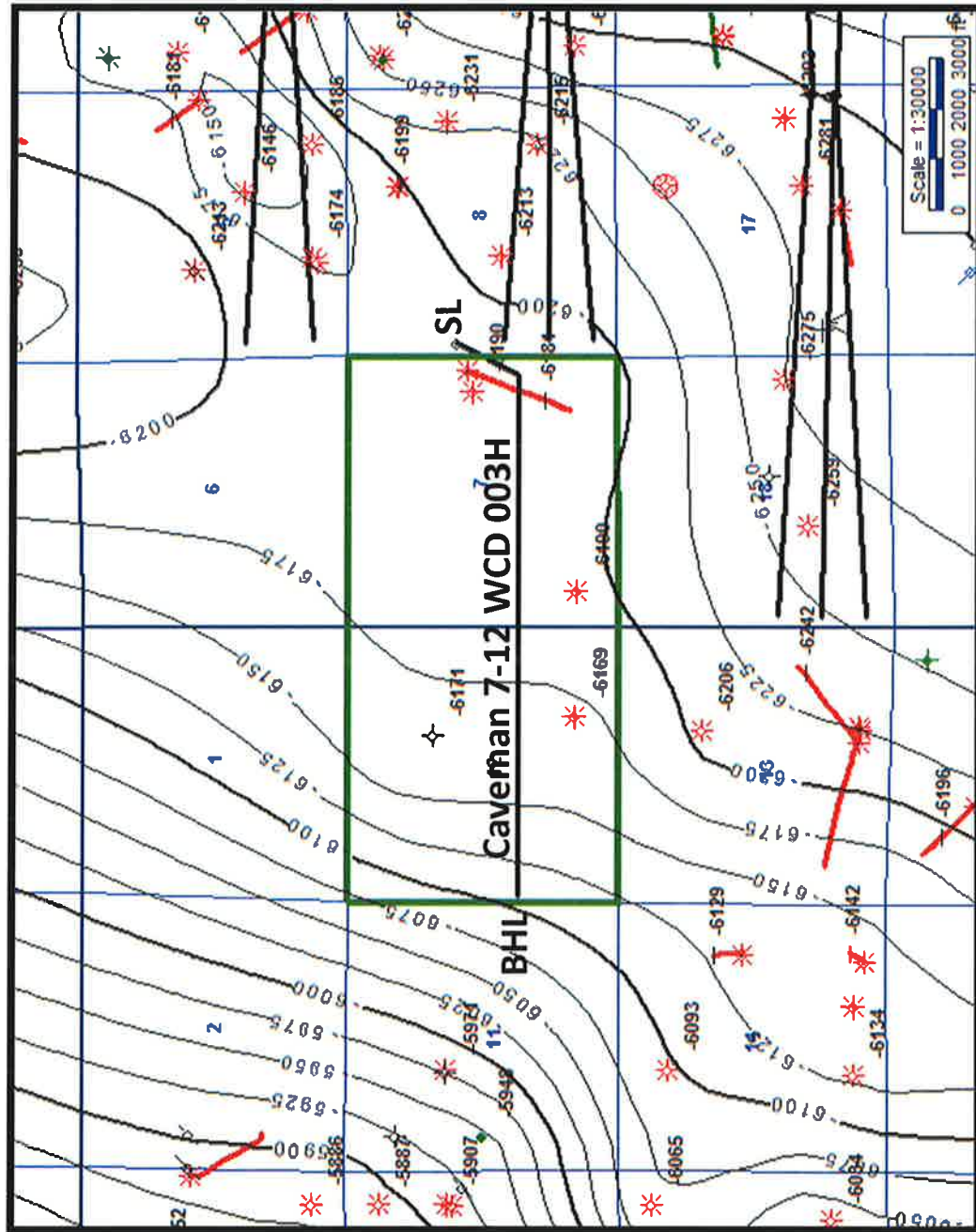

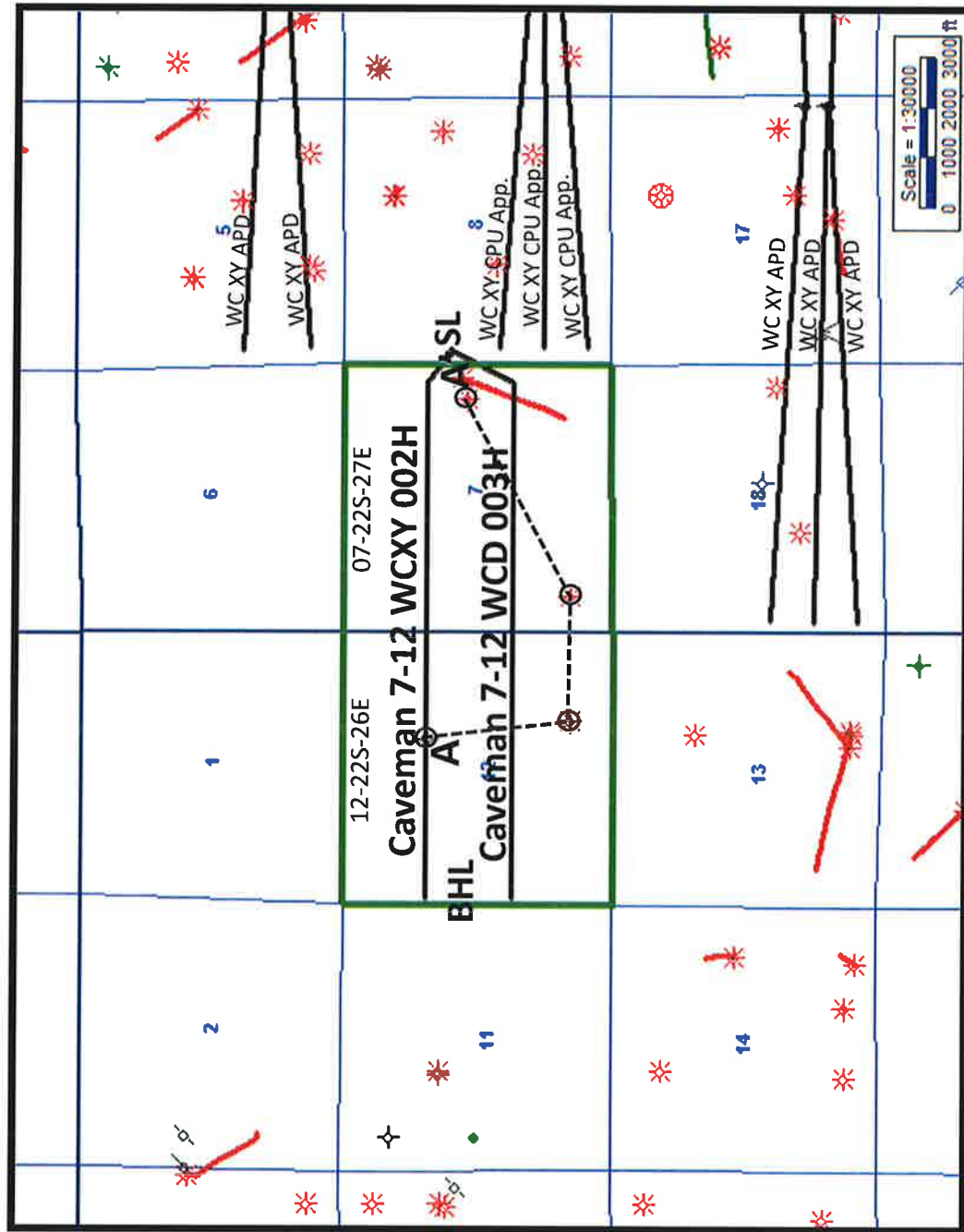

Showing A-A' Cross Section Location

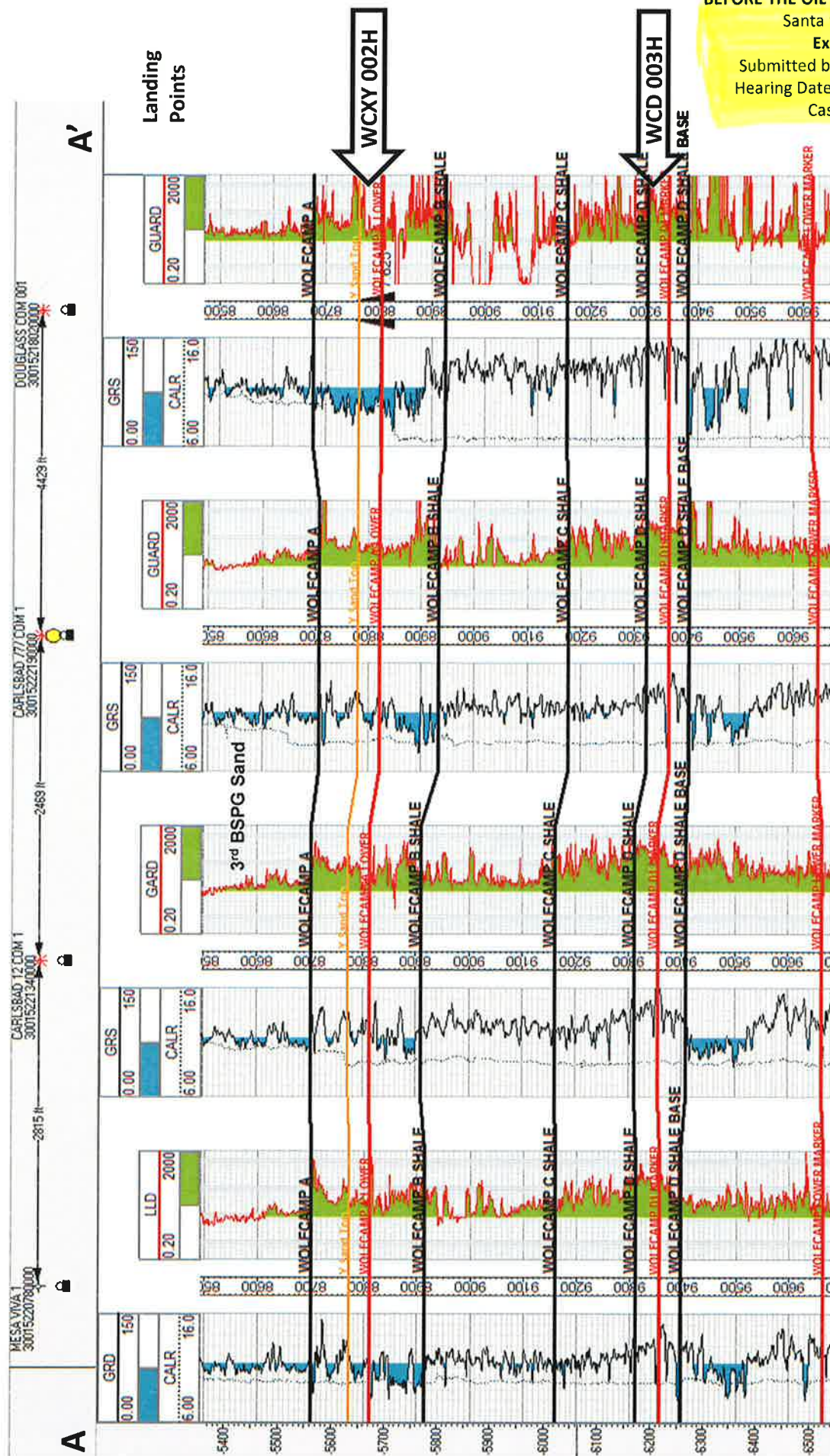
