This letter is to advise you that NGL Water Solutions Permian, LLC (“NGL”) has filed the enclosed amended application with the Oil Conservation Division (“Division”) due to a relocation of the subject well. NGL seeks an order approving disposal into the Siluro-Devonian formation through the Moab SWD #1 well at the new surface location of 892 feet from the North line and 150 feet from the West line of Section 25, Township 24 South, Range 33 East, NMPM, Lea County, New Mexico for the purpose of operating a salt water disposal well. NGL seeks authority to inject salt water into the Siluro-Devonian formation at a depth of 16,400’ to 18,004’. NGL further seeks approval of the use of 7 inch tubing inside the surface and intermediate casings and 5½ inch tubing inside the liner and requests that the Division approve a maximum daily injection rate for the well of 50,000 bbls per day.

This case is currently set for a hearing before a Division Examiner on August 22, 2019, starting at 8:15 a.m. The hearing will be held in Porter Hall in the Oil Conservation Division’s Santa Fe Office located at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505. As a party who may be affected by this application, we are notifying you of your right to appear at the hearing and participate in the case, including the right to present evidence either in support of or in opposition to the application. Failure to appear at the hearing may preclude you from any involvement in the case at a later date.




