5 of Holland & Hart on behalf of the applicant, Chisholm
6 energy.

7 HEARING EXAMINER COSS: Good morning, Ms. Luck.

11 MS. LUCK: Chisholm intends to present this case
12 by affidavit, so before you, I presented you with an exhibit
13 packet that has the three, the landman, geologist and our
14 affidavit, the notice affidavit, it is behind Tab C.

15 In this case Chisholm Energy Operating LLC has
16 applied for compulsory pooling to pool all uncommitted
17 interest in the Wolfcamp Formation underlying a standard 640
18 horizontal spacing unit in the E/2 of Section 20 and 29,
19 Township 23 South, Range 26 East, Eddy County, New Mexico,
20 and Chisholm seeks to dedicate the spacing unit to the
21 Asteroid 20-29 Fed Com WCA 1H and 2H wells.

22 As I mentioned, the notice information is found
23 behind Tab C and our office provided notice of this hearing
24 to the parties to be pooled. And out of an abundance of
25 caution, we also published notice, and that's found behind

1 Tab C1.

2 So with that I would ask that the Division accept
3 these exhibits into the record and take the case under
4 advisement.
