1 HEARING EXAMINER LOWE: At this point we would  
2 like to call Case Number 20929, Mewbourne Energy for  
3 compulsory pooling, and ask if you would like to combine  
4 20930 with 20929 and have any other entries of appearances.

5 MS. HARDY: These two applications actually  
6 involve different acreage.

7 MR. DEBRINE: Earl DeBrine with Modrall Sperling  
8 on behalf of Cimarron Energy Company.

9 MR. FELDEWERT: Mr. Examiner, Michael Feldewert  
10 with the Santa Fe office of Holland & Hart in Case 20929, we  
11 are appearing on behalf of MRC Permian Company. And in case  
12 20930, we're appearing not only on behalf of MRC Permian,  
13 but also MRC Permian LLC Company, and we do not object to  
14 either case proceeding by affidavit.

15 MR. DEBRINE: And the same is true for Cimarron.

16 HEARING EXAMINER COSS: You may proceed.

17 MS. HARDY: In case Number 20929, Mewbourne Oil  
18 Company seeks to pool all uncommitted mineral interests in  
19 the Bone Spring formation in a 240 acre, more or less,  
20 standard horizontal spacing unit comprised of the N/2 S/2 of  
21 Section 13, Township 19 South, Range 28 East, and the N/2 of  
22 the SW/4 of Section 18, Township 19 South, Range 29 East, in  
23 Eddy County.

24 The horizontal spacing unit will be dedicated to  
25 Rattlesnake 13 and 18 B2LK State Com 1H. Rattlesnake 13//18

1 B3LK State Com 1H well.

2           The exhibits I have provided to you include  
3 Exhibit 1, which is the self-affirmed statement of landman  
4 Lee Scarborough and Exhibit 2 self-affirmed statement of  
5 geologist Charles Crosby. The notice information is  
6 provided as Exhibits E and F to Mr. Scarborough's affidavit  
7 and include the sample notice letter and green card return  
8 receipt and the affidavit of the publication, and that is  
9 behind Tab F to Mr. Scarborough's affidavit.

10           So with that I would ask that Exhibits 1 and 2  
11 and their attachments be admitted into the record and that  
12 the case be taken under advisement.

13           HEARING EXAMINER COSS: Any objection?

14           MR. FELDEWERT: No objection.

15           MR. DEBRINE: No objection.

16           HEARING EXAMINER COSS: The exhibits will be  
17 admitted and Case 20929 will be taken under advisement.
