1 HEARING EXAMINER COSS: Case Number 20931,
2 application of COG Energy for compulsory pooling.

3 MS. HARDY: Good morning, Dana Hardy with the
4 Santa Fe office of Hinkle Shanor on behalf of COG Operating
5 LLC.

6 HEARING EXAMINER COSS: Good Morning, Ms. Hardy.
7 Are there any other entries in this case? Would you like to
8 consolidate Case Number 20932?

9 MS. HARDY: Sure, we can do that. I can just
10 give you a summary of each application. May I proceed?

11 HEARING EXAMINER COSS: You may.

12 MS. HARDY: Thank you. In Case Number 20931, COG
13 applies for an order pooling uncommitted mineral interests
14 in the Wolfcamp formation in the 160 acre, more or less,
15 standard horizontal spacing unit, comprised of the W/2 of
16 the E/2 of Section 18, Township 24 South, Range 34 East in
17 Lea County.

18 And in Case Number 20932, COG is seeking an order
19 pooling all uncommitted mineral interests in a 160 acre,
20 more or less, standard horizontal spacing unit comprised of
21 the E/2 of the E/2 of Section 18, Township 24 South, Range
22 34 East in Lea County.

23 The exhibits and affidavits are attached to the
24 submission I have provided you, and they establish that
25 notice was provided to the pooled parties in accordance with

1 the Commission requirements. And I ask that the exhibits be
2 admitted and the cases be taken under advisement.

3 (Exhibits 1A through F and 2A through D offered.)

4 HEARING EXAMINER COSS: Wonderful. And what tab
5 were the affidavits of notice?

6 MS. HARDY: So the landman's affidavit in both
7 cases is behind Tab 1. And the exhibits to his affidavit
8 established notice, and those are provided in both cases
9 behind Tab D, and then notice was also published in the both
10 cases, and that is behind Tab F to the landman's affidavit
11 Exhibit A.

12 HEARING EXAMINER COSS: Thank you. Cases --
13 Case Numbers 20931 and 20932 will be taken under advisement.

14 MS. HARDY: Thank you.
