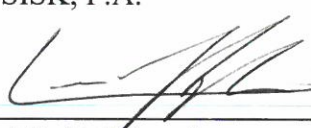
**REQUEST FOR CONTINUANCE OF FEBRUARY 6, 2020 HEARING**
