1 HEARING EXAMINER ORTH: Let's move next to 20966,
2 67 and 68, Kaiser-Francis. The well is Redhills. Call for
3 appearances.

4 MR. BRUCE: Jim Bruce of Santa Fe representing
5 the applicant and submitting the case by affidavit.

6 HEARING EXAMINER ORTH: All right. Ms. Hardy.

7 MS. HARDY: Good morning. Dana Hardy with the
8 office of Hinkle Shanor on behalf of WTG Exploration and BTA
9 Oil Producers in Case 20966, and on behalf of BTA Oil
10 Producers in 20967 and 20968.

11 HEARING EXAMINER ORTH: Mr. Feldewert?

12 MR. FELDEWERT: May it please the Examiners,
13 Michael Feldewert of the Santa Fe office of Holland & Hart
14 appearing in all three cases for COG Operating.

15 HEARING EXAMINER ORTH: COG, all right. Thank
16 you. Let me ask first, Ms. Hardy and Mr. Feldewert, do you
17 object to the matter being presented by affidavit?

18 MR. FELDEWERT: I do not.

19 MS. HARDY: No, we do not, thank you.

20 HEARING EXAMINER ORTH: Thank you. Mr. Bruce?

21 MR. BRUCE: In Case 20966, the applicant seeks to
22 force pool two mile-long Bone Spring laterals in the W/2 of
23 Section 31, 25 South, 33 East, and the W/2 of Section 6
24 immediately below that in 26, 33 East.

25 The exhibit package contains the usual landman's

1 affidavit, geologist affidavit, notice of pooling checklist,
2 et cetera. And if there is no objection, I would move that
3 the exhibits be admitted and the case be taken under
4 advisement.

5 HEARING EXAMINER ORTH: This is 20966?

6 MR. BRUCE: Yes.

7 HEARING EXAMINER ORTH: Questions?

8 EXAMINER COSS: I probably just missed it, but
9 the notice was timely?

10 MR. BRUCE: Yes.

11 EXAMINER COSS: Then no questions.

12 HEARING EXAMINER ORTH: All right. The packet is
13 accepted, and the matter will be taken under advisement.

14 (Exhibits 1 through 5 admitted.)

15 (Case 20966 taken under advisement.)

16 MR. BRUCE: In all of these, there is no
17 published notice. That was not necessary in these cases.

18 HEARING EXAMINER ORTH: Not necessary because
19 there were no unknown persons?

20 MR. BRUCE: Correct. In Cases 20967 and 20968,
21 the applicant seeks to force pool two mile laterals in the
22 E/2 of Section 31 and the E/2 of Section 6.

23 20967 is for the Bone Spring, 20968 is for the
24 Wolfcamp. Interest ownership is common throughout the well
25 units, and these are proximity tracts, so the exhibit pack

1 contains all the requirements of the Division, and if there
2 is no objection, move the admission of Exhibits 1 through 5
3 in each case.

4 HEARING EXAMINER ORTH: Questions?

5 EXAMINER COSS: I don't have any questions.

6 HEARING EXAMINER ORTH: All right. Thank you
7 very much, Mr. Bruce. Both packets will be accepted in
8 matters 20967 and 20968 and the matters will be taken under
9 advisement.
