Hi Jennifer,

I need to provide confirmation to OCD that Marathon had notice of FME's above captioned cases going to hearing today, August 5, and that Marathon did not object to FME presenting the cases by affidavit. As you and I discussed, via a series of emails, you and I discussed these cases and that they were set for hearing today. It is my understanding that FME also emailed Marathon landmen about these cases.
