MOTION TO DISMISS CASES 21684 & 21686, TO SUBSTITUE CASES 22103 & 22104 IN THE PREHEARING ORDER AND TO CONTINUE THESE SUBSTITUTED CASES TO THE OCTOBER 21ST HEARING DOCKET

Matador Production Company ("Matador"), through its undersigned attorneys, moves the New Mexico Oil Conservation Division to:

- (a) dismiss pooling Cases 21684 and 21686,
- (b) substitute Cases 22103 and 22104 for Cases 21684 and 21686 in the Prehearing Order entered by the Division on July 15, 2021, in Case Nos. 21683-21686 (Matador applications) and Cases 22083-22084 (Applications filed by E.G.L. Resources, Inc.), and
- (c) continue Cases 22103 and 22104, currently on the September 9th docket, to the October 21, 2021, contested hearing docket.

Matador's Amended Applications filed in Cases 22103 and 22104 replace the pooling sought under Cases 21684 and 21686 and involve the acreage at issue under the competing pooling applications scheduled to be heard on October 21, 2021. Accordingly, Cases

21684 and 21686 should be dismissed and the Amended Applications filed in Cases 22103 and 22104 should be moved to the October 21st docket for consolidation with the remaining cases subject to the Prehearing Order.

Counsel of record in these matters have been contacted. Counsel for intervenor EOG Resources has been contacted and does not oppose this motion. Counsel for E.G.L. has not received a response from his client on this motion.
