APPLICANT'S STATEMENT OF CASE

Under these consolidated cases, EOG seeks orders from the Division pooling additional interest owners under the W/2 W/2 of Section 10, and the W/2 SW/4 of Section 3, Township 25 South, Range 34 East, NMPM, Lea County, New Mexico, as follows:

- Under **Case 22126**, EOG seeks to pool additional interest owners under the terms of Order No. R-14371 (issued in Case 15667), which created a standard 240-acre horizontal spacing unit in the Bone Spring formation underlying the subject acreage and which is currently dedicated to the Osprey 10 #602H (30-025-43650) and the Osprey 10 #301H (30-025-44839) wells.
- Under **Case 22130**, EOG seeks to pool additional interest owners under the terms of Order No. R-14364 (issued in Case 15666), which created a standard 240-acre horizontal spacing unit in the Wolfcamp formation underlying the subject acreage and which is currently dedicated to the Osprey 10 #701H (30-025-43651) and the Osprey 10 705H (30-025-44175) wells.

Since the entry of these pooling orders, EOG has determined that there are additional interest owners in the pooled spacing units which were not provided notice of the hearings resulting in the issuance of these pooling orders and which are not under a voluntary agreement consolidating the subject acreage.
