**APPLICANT'S STATEMENT OF CASE**

Ameredev seeks an order (1) pooling all uncommitted interest in the Wolfcamp formation ((Jal; Wolfcamp, West Pool [33813])) underlying a standard 640-acre, more or less, horizontal spacing unit comprised of the W/2 of Sections 20 and 17, Township 25 South, Range 36 East, N.M.P.M., Lea County, New Mexico, and (2) dedicating the above-referenced horizontal spacing

unit to the proposed initial **Dogwood Fed Com 25 36 20 #112H well** to be drilled from a surface hole location in the SW/4 SW/4 (Unit M) of Section 20, to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 17. The completed interval for the well will remain within 300 feet from the quarter-quarter line separating the E/2 W/2 from the W/2 W/2 to allow inclusion of this acreage into a standard horizontal spacing unit.
