**NOTICE OF FILING AMENDED APPLICATION AND REQUEST TO UPDATE  
DOCKET VERBIAGE--CIMAREX CASE NO. 22313**

Cimarex Energy Co. ("Cimarex"), through its undersigned attorneys, hereby provides notice that on December 27, 2021, Cimarex filed an amended application in Case No. 22313. Cimarex inadvertently did not include the Coriander 1-12 Fed Com 31H well in its original application or in the notice paragraph that appears in the Oil Conservation Division's ("Division") dockets. Cimarex filed the amended application to correct the oversight regarding the Coriander 1-12 Fed Com 31H well. Case No. 22313 as well as other Cimarex cases, along with Devon Energy Production Company, L.P. competing cases, are set for the Division's February 3, 2022 docket pursuant to a Division issued pre-hearing order.<sup>1</sup> Cimarex respectfully requests that the Division update the Division's February 3, 2022 docket information to reflect the amended application verbiage, which Cimarex submitted with its amended application.
