APPLICANT'S STATEMENT OF CASE

Spur seeks to amend Order No. R-21579 (the "Order") to allow for a one year extension for drilling the proposed initial well under the Order. Order No. R-21579, entered on January 21, 2021, in Case No. 21586, created a standard 160-acre horizontal spacing unit in the Yeso formation, from the top of the Yeso formation to a depth of 3,000 feet, underlying the N/2 S/2 of Section 18, Township 18 South, Range 27 East, NMPM,

Eddy County, New Mexico (the "Unit"), and designated Applicant as the operator of the Unit. The Unit was designated to the proposed initial Smashing Pumpkins #1H well. Order No. R-21579 required the drilling of the initial well by January 21, 2022. Spur requests a one-year extension of time to drill the initial well under the Order, until January 21, 2023.
