## APPLICANT'S STATEMENT OF CASE

Spur seeks to amend Order No. R-21580 (the "Order") to allow for a one year extension for drilling the proposed initial well under the Order. Order No. R-21580, entered on January 19, 2021, in Case No. 21587, created a standard 160-acre horizontal spacing unit in the Yeso formation, from a depth of 3,001 feet to the base of the Yeso formation, underlying the N/2 S/2 of Section 18, Township 18 South, Range 27 East,

NMPM, Eddy County, New Mexico (the "Unit"), and designated Applicant as the operator of the Unit. The Unit was designated to the proposed initial (1) the Smashing Pumpkins #10H well, (2) the Smashing Pumpkins #50H well, and (3) the Smashing Pumpkins #70H well. Order No. R-21580 required the drilling of the initial well by January 19, 2022. Spur requests a one-year extension of time to drill the initial well under the Order, until January 19, 2023.
