APPLICANT'S MOTION TO TAKE CASE UNDER ADVISEMENT

Novo Oil & Gas Northern Delaware, LLC ("Applicant") (OGRID No. 372920), by and through counsel, moves the New Mexico Oil Conservation Division (the "Division") to take Case No. 22615 under advisement instead of continuing the matter until the May 5, 2022 docket. In support thereof, Novo states as follows:

1. Undersigned counsel presented Case No. 22615 at the April 7, 2022 hearing.
2. The exhibit packet, including **Novo Exhibits A, A-1, A-2, A-3, A-4, B, B-1, B-2, B-3, B-4, C, and D** were accepted by the Division and made part of the record.
3. At undersigned counsel's request, the hearing was continued to May 5, 2022 in order for Novo to give notice to a single uncommitted working interest owner, Slaton Resources II, LLC ("Slaton Resources").
4. Since then, Novo has reached an agreement with Slaton Resources. Because it is no longer seeking to compulsorily pool Slaton Resources, Novo no longer needs to continue the case to give notice to Slaton Resources. *See* Affidavit of Brandon Patrick, dated April 8, 2022, attached hereto as **Exhibit 1**.
5. Accordingly, Novo wishes Case No. 22615 to be taken under advisement immediately, without need to continue the matter until the May 5, 2022 docket.

6. There are no other parties to this matter, *see* 19.15.4.10 NMAC, and therefore this motion is unopposed.

WHEREFORE, Novo respectfully requests the Division to grant this motion and take Case No. 22615 under advisement.
