**SELF-AFFIRMED STATEMENT
OF VANESSA NEAL**

1. I am a Senior Reservoir Engineer at FAE II, LLC (“FAE”) and am over 18 years of age. I have personal knowledge of the matters addressed herein and am competent to provide this Self-Affirmed Statement. I have previously testified before the New Mexico Oil Conservation Division (“Division”) and my credentials as an expert in petroleum engineering were accepted and made a matter of record.

2. I am familiar with the engineering matters that pertain to this matter.

3. FAE currently operates approximately 600 oil and gas wells in the Commingling Area¹ that produce from the Yates, Seven Rivers, Queen, and Grayburg formations. The pools from which these wells produce, and that FAE seeks to commingle (“Commingling Pools”), are:

4. The Division routinely approves applications for downhole commingling in these pools within the Commingling Area. FAE has filed numerous applications for downhole commingling in the Commingling Area and intends to file many more in the near future.

5. Allowing FAE to submit future commingling applications via Form C-103 will reduce administrative burdens for the Division and FAE.

6. A map that identifies wells in the Commingling Pools and Commingling Area that have previously been approved for downhole commingling is attached as **Exhibit C-1**.

7. A list of previous orders authorizing commingling for the pools and area is attached as **Exhibit C-2**.

8. The bottom perforation of the lower zone is within 150 percent of the depth of the top perforation in the upper zone and the lower zone is at or below normal pressure with normal pressure assumed to be 0.433 psi per foot of depth.

9. Production curves for each zone for at least one year are attached as **Exhibit C-3**.

10. The last 5 years of production data from each zone across the Commingling Area was used to create a normalized allocation for all zones; this is attached as **Exhibit C-4**. FAE recommends that well specific allocations be included on Form C-103 to reduce influence of large area skewing factors, e.g. waterflood response, completion intervals, etc.

11. Based on my review of the wells in the Commingling Pools and Commingling area that have previously been approved for downhole commingling, it is my opinion that commingling will not jeopardize the efficiency of present or future secondary recovery operations in the pools to be commingled.

12. The proposed commingling will not result in the permanent loss of reserves due to cross-flow in the well bore.

13. The allocated production from each producing pool in the commingled well bore will not exceed the top oil or gas allowable rate for a well in that pool or rate restriction applicable to the well.

14. The proposed commingling will not reduce the value of the total remaining production.

15. Pre-approval of downhole commingling within the Commingling Area will extend the economic life of the existing wells and increase ultimate recovery from the formations.

16. One or more of the zones contained in the Commingling Area is of marginal production capacity based on recent production rates of wells producing from a single zone.

17. Based on my analysis and Mr. Hooper's analysis, sufficient data exists within the Yates, Seven Rivers, Queen, and Grayburg formations to support granting of exceptions from the criteria contained in Rule 19.15.12.11(A).

18. In my opinion, the granting of FAE's application will serve the interests of conservation, the protection of correlative rights, and the prevention of waste.

19. The exhibits attached hereto were either prepared by me or under my supervision or were compiled from company business records.

20. I understand this Self-Affirmed Statement will be used as written testimony in this case. I affirm my testimony above is true and correct and is made under penalty of perjury under the laws of the State of New Mexico. My testimony is made as of the date identified next to my signature below.


