STATEMENT OF THE CASE

In Case No 23102, Applicant applies for an order pooling all uncommitted interests within the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit

comprised of the E/2 SE/4 of Section 29 and the E/2 E/2 of Section 32, Township 21 South, Range 35 East, Lea County, New Mexico. The spacing unit will be dedicated to the following wells:

- **Cache River 29 32 State Com #104H well**, to be drilled from a surface hole location in the NE/4 SE/4 (Unit I) of Section 29, Township 21 South, Range 35 East, to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 32, Township 21 South, Range 35 East;
- **Cache River 29 32 State Com #204H well**, to be drilled from a surface hole location in the NE/4 SE/4 (Unit I) of Section 29, Township 21 South, Range 35 East, to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 32, Township 21 South, Range 35 East; and
- **Cache River 29 32 State Com #304H well**, to be drilled from a surface hole location in the NE/4 SE/4 (Unit I) of Section 29, Township 21 South, Range 35 East, to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 32, Township 21 South, Range 35 East.

In **Case No. 23103**, Applicant applies for an order pooling all uncommitted interests within the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the E/2 SW/4 of Section 29 and the E/2 W/2 of Section 32, Township 21 South, Range 35 East, Lea County, New Mexico. The spacing unit will be dedicated to the following wells:

- **Cache River 29 32 State Com #102H well**, to be drilled from a surface hole location in the NE/4 SW/4 (Unit K) of Section 29, Township 21 South, Range 35 East, to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 32, Township 21 South, Range 35 East;

- **Cache River 29 32 State Com #202H well**, to be drilled from a surface hole location in the NE/4 SW/4 (Unit K) of Section 29, Township 21 South, Range 35 East, to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 32, Township 21 South, Range 35 East; and
- **Cache River 29 32 State Com #302H well**, to be drilled from a surface hole location in the NE/4 SW/4 (Unit K) of Section 29, Township 21 South, Range 35 East, to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 32, Township 21 South, Range 35 East.

In **Case No. 23104**, Applicant applies for an order pooling all uncommitted interests within the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the W/2 SW/4 of Section 29 and the W/2 W/2 of Section 32, Township 21 South, Range 35 East, Lea County, New Mexico. The spacing unit will be dedicated to the following wells:

- **Cache River 29 32 State Com #101H well**, to be drilled from a surface hole location in the NW/4 SW/4 (Unit L) of Section 29, Township 21 South, Range 35 East, to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 32, Township 21 South, Range 35 East;
- **Cache River 29 32 State Com #201H well**, to be drilled from a surface hole location in the NW/4 SW/4 (Unit L) of Section 29, Township 21 South, Range 35 East, to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 32, Township 21 South, Range 35 East; and
- **Cache River 29 32 State Com #301H well**, to be drilled from a surface hole location in the NW/4 SW/4 (Unit L) of Section 29, Township 21 South, Range 35

East, to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 32, Township 21 South, Range 35 East.

The completed intervals of the wells will be orthodox. Also to be considered in each case will be the cost of drilling and completing the Wells and the allocation of the costs, the designation of Applicant as the operator of the Wells, and a 200% charge for the risk involved in drilling and completing the Wells.

The wells are located approximately 13 miles West of Eunice, New Mexico.
