In Case No. 23117, V-F Petroleum seeks an order (1) establishing a standard 320-acre, more or less, spacing and proration unit comprised of the S/2 N/2 of Sections 33 and 34, Township 18 South, Range 28 East, NMPM, Eddy County, New Mexico, and (2) pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying said unit. V-

F Petroleum proposes and dedicates to the unit the Walker 34-33 State Com #223H Well and the Walker 34-33 State Com #233H Well as initial wells. The wells will be orthodox in location.

V-F Petroleum proposes the Walker 34-33 State Com #223H Well, an oil well, to be horizontally drilled from a surface location in the SE/4 NE/4 (Unit H) of Section 34 to a bottom hole location in the SW/4 NW/4 (Unit E) of Section 33.

V-F Petroleum proposes the Walker 34-33 State Com #233H Well, an oil well, to be horizontally drilled from a surface location in the SE/4 NE/4 (Unit H) of Section 34 to a bottom hole location in the SW/4 NW/4 (Unit E) of Section 33.
