1. I am a landman with V-F Petroleum, Inc. (“V-F Petroleum”). I am over 18 years of age, have personal knowledge of the matters addressed herein, and am competent to provide this Self-Affirmed Statement. I have previously testified before the New Mexico Oil Conservation Division (“Division”) and my credentials as an expert in petroleum land matters were accepted and made a matter of record.

2. At the November 3, 2022 hearing, the Division requested that V-F Petroleum provide information regarding the acreage in the W/2 E/2 of Section 32 and the W/2 SE/4 of Section 29, Township 21 South, Range 35 East, Lea County, New Mexico, that is not included within the cases referenced above. Specifically, the Division asked V-F Petroleum to confirm that this acreage will not be stranded as a result of these applications.

3. V-F Petroleum plans to develop the W/2 E/2 of Section 32 and the W/2 SE/4 of Section 29, has already proposed wells in this acreage, and intends to file a pooling application within the next few months. Accordingly, this acreage will not be stranded.

4. I understand this Self-Affirmed Statement will be used as written testimony in these cases. I affirm that my testimony above is true and correct and is made under penalty of perjury under the laws of the State of New Mexico.
