SUPPLEMENTAL SELF-AFFIRMED STATEMENT OF SEAN JOHNSON

I, Sean Johnson, being duly sworn on oath, state the following:

- 1. I am over the age of eighteen years and have the capacity to execute this Affidavit, which is based on my personal knowledge.
- 2. I am employed as a Landman with V-F Petroleum, Inc., ("V-F Petroleum") and testified by affidavit as an expert witness in petroleum land matters in the hearing for Case No. 23118 held before the New Mexico Oil Conservation Division ("Division") on November 3, 2022.
- 3. During the hearing, the hearing examiners asked about the status of N/2 NE/4 of Section 34, Township 18 South, Range 28 East, Eddy County, New Mexico ("N/2 NE/4").
- 4. In response to the hearing examiners' inquiry about the N/2 NE/4 and the concern of acreage not being developed, I take this opportunity to assure the Division that V-F Petroleum will be developing that acreage, the N/2 NE/4, with its Burns 34/35 State Com #222H and #232H wells comprising the N/2 NE/4 of Section 34 and N/2 NW/4 of Section 35 in the same township and range. The Case No. 23041 for the Burns 34/35 State Com was heard by the Division on October 6, 2022, and taken under advisement. The remaining acreage in Sections 35 and 36 of the same township and range will be developed by Mewbourne in collaboration with V-F Petroleum, a joint effort that will fully develop Sections 36, 35, 34, and 33, Township 18 South, Range 28 East, NMPM, and no acreage will be stranded.
