I, Matthew Hoops, being duly sworn on oath, state the following:

1. I am over the age of eighteen years and have the capacity to execute this Affidavit, which is based on my personal knowledge.


2. I am employed as a Landman with Devon Energy Production Company L.P. (“Devon”) and testified by affidavit as an expert witness in petroleum land matters in the hearing for Case Nos. 23147 and 23148 held before the New Mexico Oil Conservation Division (“Division”) on November 3, 2022.

3. At the hearing held on November 3, 2022, there was some question about the method Devon intended to use to seek approval for the Non-standard Proration Units (“NSPs”) it had requested in the two Case Nos. 23147 and 23148. The intent of Devon’s request for approval of the NSPs was and is for approval of the NSPs to be sought through the administrative process as a separate application process and not as part of the hearing held on November 3, 2022, except to notify the OCD that Devon is seeking approval of the NSPs through the administrative process. Any request for approval of the NSPs in the exhibits and at the hearing was intended only to inform the OCD that Devon is seeking approval for the NSPs through the OCD’s

separate administrative process. Devon had filed its NSP applications as separate applications and is currently working with the OCD to pursue approval of the NSPs in this manner.

I understand that this Supplemental Self-Affirmed Statement will be used as written testimony before the Division in Case Nos. 23147 & 23148 and affirm that my testimony herein is true and correct, to the best of my knowledge and belief, and made under penalty of perjury under the laws of the State of New Mexico.
