

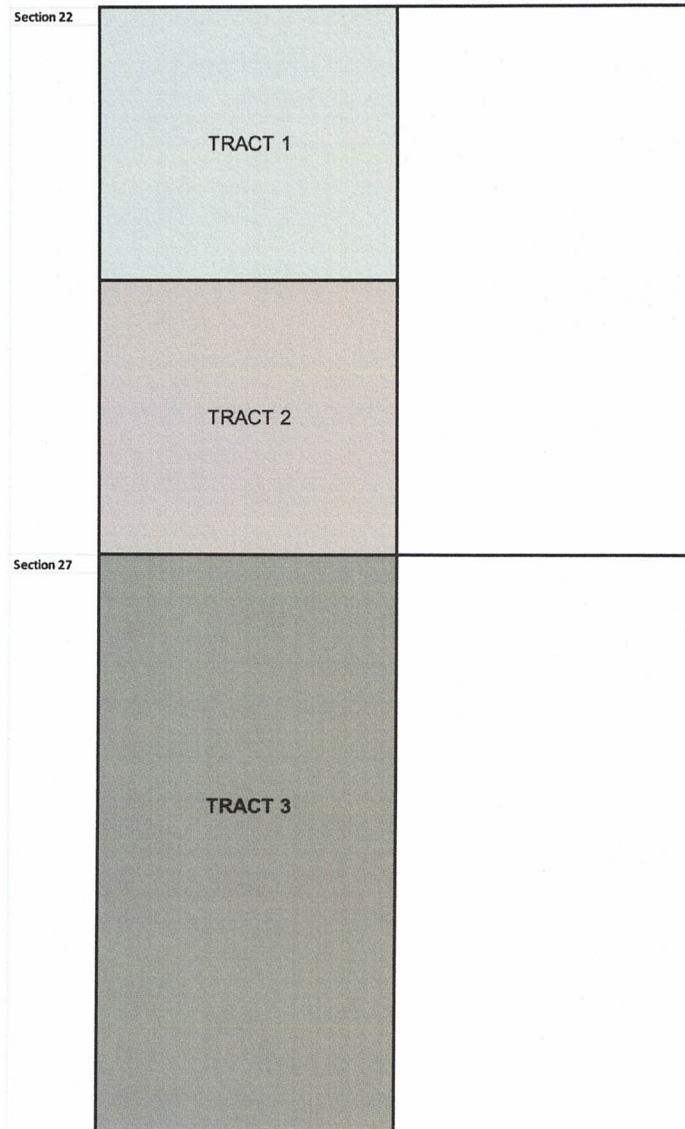

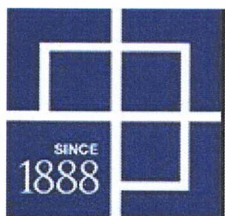

These cases are set for 11/17 (uncontested). When I gave notice last March Chisholm was still owner of record, and I sent notice to them. I was subsequently told they forwarded them to Earthstone.
