APPLICANT'S STATEMENT OF CASE

In Case No. 23187, Applicant seeks an order pooling all uncommitted mineral interests in the Bone Spring formation [Red Tank, Bone Spring Pool (Pool Code 51683)] underlying a standard 480-acre, more or less, horizontal well spacing unit comprised of the W/2 W/2 of Sections 1 and 12, Township 22 South, Range 32 East, and the W/2 W/2 of Section 36, Township 21 South, Range 32 East, NMPM, Lea County, New Mexico. Applicant seeks to initially dedicate the above-referenced horizontal spacing unit to the following proposed well:

PAW SWAP 12-36 FED COM #21H well to be drilled from a surface location in
the NE/4 NW/4 (Unit C) of Section 13, Township 22 South, Range 32 East, NMPM,
Lea County, to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 36,
Township 21 South, Range 32 East, NMPM, Lea County. A portion of the well
location is within the potash development area.

This well is proposed to be drilled vertically to a depth of approximately 9,510' to the Bone Spring formation and laterally in a northerly direction within the formation to the referenced bottom hole location. The well will comply with the Division's statewide setback requirements.

That Order designates Applicant as the operator of the same spacing unit as proposed in this case No. 23187, dedicates a single well, the Paw Swap 12-36 Fed Com #11H to the spacing unit, and pools all uncommitted interests. In the application in this case No. 23187, OXY seeks to dedicate an additional well to the same spacing unit. Rather than issue a separate Order in case No. 23187, now that an Order has been issued in Case No. 22928, it would be appropriate to consolidate this case with Case No. 22928 and, if OXY's application in
