STATEMENT OF THE CASE

Mewbourne seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 240.45-acre, more or less, standard horizontal spacing unit comprised of Lots 1 and 2 (N/2 NE/4 equivalent) of irregular Section 6 and Lots 1 through 4 (N/2 N/2 equivalent) of Section 5, Township 18 South, Range 32 East in Lea County, New Mexico (“Unit”). The Unit will be dedicated to the Winterfell 6/5 B2BA Fed Com #1H well (“Well”), which will be horizontally

drilled from a surface hole location in Lot 2 (NW/4 NE/4) of irregular Section 6 to a bottom hole location in Lot 1 (NE/4 NE/4) of Section 5. The completed interval of the Well will be orthodox.

Also to be considered will be the cost of drilling and completing the Well and the allocation of the costs, the designation of Applicant as the operator of the Well, and a 200% charge for the risk involved in drilling and completing the Well.

The Well is located approximately 6 miles southwest of Maljamar, New Mexico.
