Gentlemen:

The Carson Unit NMNM078385X, San Juan County, New Mexico, was approved November 15, 1956. An Amendment to the Unit Agreement was approved and effective as of **1st day of July 1, 2022**. Request for final approval for expansion of the unit was received by letter dated October 6, 2022. All the requirements set forth in Section 2 of the unit agreement have been fulfilled. Said expansion is hereby approved **effective October 1, 2022**. Our approval is subject to like approval by the New Mexico State Commissioner of Public Lands.

The Carson Unit Agreement as amended and submitted for the area designation is for all oil and gas in the Mancos formation of the unitized lands, defined as that interval located from below the stratigraphic equivalent of the top of the Mancos Shale (base of Mesa Verde Group) identified at 3,736' MD to the stratigraphic equivalent of the base of the Mancos Shale (base of Greenhorn Limestone) identified at 5,526' MD as shown in the Central Bisti SWD 161 well (API # 30-045-31606) located in Township 25 North, Range 12 West, Section 16, San Juan County, New Mexico”

The basic information is as follows:

1. The expansion of the unit area was given preliminary approval by Bureau of Land Management letter dated June 29, 2020. This preliminary approval was revised again on December 12, 2021, at the request of the operator due to ongoing negotiations.

2. This expansion will add 16,148.84 acres to the existing 7,084.13 acres, resulting in an enlarged unit area of 23,232.97 acres, more or less, of which 17,870.87 acres (76.920299%) are Federal lands, and 1,360.00 acres (5.853750%) are State lands, and 4,002.10 acres (17.225951%) are Navajo Allotted lands.

In view of the foregoing commitment status, effective control of operations within the expanded unit area is assured. We are of the opinion that the expansion is necessary and advisable in the public interest for the purpose of more properly conserving natural resources.

The unit agreement amendment embraces 23,232.97 acres more or less, of which 17,870.87 acres (76.920299%) are Federal lands, and 1,360.00 acres (5.853750%) are State lands, and 4,002.10 acres (17.225951%) are Navajo Allotted lands.

DJR submits the Exhibits “A” and “B” with full authority and joinder of all associated Record Title, Operating Rights, and Overriding Royalty owners.

In view of the foregoing commitment status, effective control of operations within the unit area is assured. We are of the opinion that the agreement amendment is necessary and advisable in the public interest and for the purpose of more properly conserving natural resources.

This unit expansion provides for the drilling of one obligation well to test the Mancos formation with at least a 1-mile horizontal well on the extended acreage pursuant to Section 9 of the Unit Agreement. The obligation well is considered a contractual commitment on the part of the Unit Operator. No extension of time will be granted to commence the obligation well other than under the provisions of Section 9 and/or Section 25 of the Unit Agreement, where justified. Any extension granted requires convincing written justification and documentation prior to the critical date and is limited to 30 days with possible renewal for 30-day periods if the delay is extensive, with timely written documentation for each extension. The operation approved to meet this obligation is the re-entry of the existing vertical borehole currently named the Carson 615H (API #30-045-35878), and the drilling of a 7,500-foot (or minimum of one mile) horizontal lateral to be approximately located in Sections 17, 20 and 21, T.25N, R.12W. The re-entry and drilling operation must commence within 6 months after approval of the unit expansion. (This timeline will be from the effective date of the Unit Agreement for the expansion.). Said obligation shall be considered the Public Interest Requirement pursuant to 43 CFR 3183.4(b). Should you fail to meet the Public Interest Requirement, this expansion will be invalidated ab initio.

The unit operator shall submit to the Authorized Officer an application for a participating area with sufficient technical justification as soon as practicable upon completion of the obligation wells in their respective formations.

Pursuant to 43 CFR 3183.4(b) and Section 9 of the Unit Agreement, if the Public Interest Requirement is not fulfilled, the unit extension will be declared invalid, and no Federal lease committed to this agreement shall receive the benefits of 43 CFR 3107.3-2 and 3107.4.

Approval of this agreement does not warrant or certify that the operator thereof and other holders of operating rights hold legal or equitable title to those rights in the subject leases which are committed hereto.

All unit wells shall be operated by the Unit Operator and all unit wells shall be named after the unit's name with consecutive and or unique well numbers .

Copies of the approved agreement are being distributed to the appropriate Federal offices. You are requested to furnish all interested parties with appropriate evidence of this approval. If you have any questions, please contact Edward Fernandez at efernand@blm.gov.

As provided in 43 CFR 3165.3(b), you may request an administrative review of this decision before the State Director. Per 43 CFR 3165.4, you may appeal any instructions, orders, or decisions issued by the BLM New Mexico State Office directly to the Interior Board of Land Appeals pursuant to the regulations found at 43 CFR 4. A copy of Form 1842-1, Information on Taking Appeals to the Interior Board of Land Appeals, is enclosed.


